## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **State Brain Injury Trust Fund**

3 FOR the purpose of establishing the State Brain Injury Trust Fund as a special fund  
4 to be used to support certain services for certain individuals with brain injuries;  
5 requiring the Secretary of Health and Mental Hygiene or the Secretary's  
6 designee to administer the Fund; requiring the Secretary or the Secretary's  
7 designee to report to the Governor and the General Assembly on or before a  
8 certain date each year; establishing eligibility for individuals to receive  
9 assistance from the Fund; requiring that certain investment earnings be  
10 credited to the Fund; ~~altering the amount of a certain motor vehicle registration~~  
11 ~~fee surcharge; requiring that a certain amount of the motor vehicle registration~~  
12 ~~fee surcharge be paid into the Fund;~~ defining certain terms; and generally  
13 relating to the establishment of the State Brain Injury Trust Fund.

19 MARYLAND, That the Laws of Maryland read as follows:

29 THE POLICIES AND PROCEDURES ADOPTED BY THE STATE TRAUMATIC BRAIN  
30 INJURY ADVISORY BOARD UNDER § 13–2105 OF THIS TITLE.

32 (A) THERE IS A STATE BRAIN INJURY TRUST FUND.

1           **(B) (1) THE PURPOSE OF THE FUND IS TO ASSIST IN THE PROVISION**  
2 **OF THE FOLLOWING SERVICES TO ELIGIBLE INDIVIDUALS WHO HAVE**  
3 **SUSTAINED BRAIN INJURIES:**

6           **(2) THE FUND MAY BE USED TO SUPPORT:**

21                  **(XII) HOUSING AND RESIDENTIAL SERVICES; AND**

22                  **(XIII) TRANSPORTATION SERVICES.**

23           **(C) THE SECRETARY OR THE SECRETARY'S DESIGNEE SHALL**  
24 **ADMINISTER THE FUND.**

25           **(D) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT**  
26 **SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.**

1           (2) THE STATE TREASURER SHALL HOLD THE FUND  
2 SEPARATELY, AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.

3           (E) THE FUND CONSISTS OF:

4           (1) ~~MOTOR VEHICLE REGISTRATION SURCHARGES PAID INTO THE~~  
5 ~~FUND IN ACCORDANCE WITH § 13-954(B)(3) OF THE TRANSPORTATION~~  
6 ~~ARTICLE;~~

7           ~~(2)~~ MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND;

8           ~~(3)~~ (2) INVESTMENT EARNINGS OF THE FUND; AND

9           ~~(4)~~ (3) ANY OTHER MONEY FROM ANY OTHER SOURCE  
10 ACCEPTED FOR THE BENEFIT OF THE FUND.

11           (F) THE FUND MAY BE USED ONLY TO PROVIDE FUNDING FOR THE  
12 PURPOSE DESCRIBED IN SUBSECTION (B) OF THIS SECTION.

13           (G) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE  
14 FUND IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.

15           (2) ANY INVESTMENT EARNINGS OF THE FUND SHALL BE  
16 CREDITED TO THE FUND.

17           (H) MONEY EXPENDED FROM THE FUND TO SUPPORT SERVICES TO  
18 INDIVIDUALS WITH BRAIN INJURIES IS SUPPLEMENTAL TO AND IS NOT  
19 INTENDED TO TAKE THE PLACE OF FUNDING THAT WOULD OTHERWISE BE  
20 APPROPRIATED FOR THOSE SERVICES.

21           (I) ON OR BEFORE DECEMBER 1 OF EACH YEAR, THE SECRETARY OR  
22 THE SECRETARY'S DESIGNEE SHALL SUBMIT A REPORT TO THE GOVERNOR  
23 AND, IN ACCORDANCE WITH § 2-1246 OF THE STATE GOVERNMENT ARTICLE,  
24 THE GENERAL ASSEMBLY ON THE NUMBER OF INDIVIDUALS SERVED AND THE  
25 SERVICES PROVIDED IN THE PRECEDING FISCAL YEAR USING THE FUND.

27           (A) TO BE ELIGIBLE FOR ASSISTANCE FROM THE FUND, AN INDIVIDUAL  
28 SHALL:

29           (1) BE A UNITED STATES CITIZEN AND A RESIDENT OF THE  
30 STATE AT THE TIME OF THE BRAIN INJURY;

1           **(2) HAVE A BRAIN INJURY THAT HAS BEEN DOCUMENTED IN THE**  
 2 **MEDICAL RECORDS OF THE INDIVIDUAL;**

3           **(3) HAVE INCOME AT OR BELOW 300% OF THE FEDERAL POVERTY**  
 4 **LEVEL; AND**

5           **(4) HAVE EXHAUSTED ALL OTHER HEALTH, REHABILITATION,**  
 6 **AND DISABILITY BENEFIT FUNDING SOURCES THAT COVER THE SERVICES**  
 7 **PROVIDED BY THE FUND.**

8           **(B) AN INDIVIDUAL MAY NOT RECEIVE SERVICES FROM THE FUND**  
 9 **COSTING MORE THAN:**

10           **(1) THE ANNUAL AMOUNT ESTABLISHED BY POLICIES AND**  
 11 **PROCEDURES ADOPTED BY THE SECRETARY OR THE SECRETARY'S DESIGNEE;**  
 12 **AND**

13           **(2) THE LIFETIME OF THE INDIVIDUAL AMOUNT ESTABLISHED BY**  
 14 **POLICIES AND PROCEDURES ADOPTED BY THE SECRETARY OR THE**  
 15 **SECRETARY'S DESIGNEE.**
