A BILL ENTITLED

1 AN ACT concerning

2 **Virginia I. Jones Alzheimer’s Disease and Related Disorders Council**

3 FOR the purpose of establishing the Virginia I. Jones Alzheimer’s Disease and Related
4 Disorders Council; providing for the membership of the Council; requiring the
5 Secretary of Health and Mental Hygiene and the Secretary of Aging to cochair
6 the Council; requiring the Department of Health and Mental Hygiene to provide
7 staff support for the Council; authorizing the Department to request certain
8 staffing assistance; providing that a member of the Council may not receive
9 certain compensation but is entitled to certain reimbursement; providing for the
10 duties of the Council; defining a certain term; and generally relating to the
11 Virginia I. Jones Alzheimer’s Disease and Related Disorders Council.

12 BY adding to

13 Article – Health – General

14 Section 13–3101 through 13–3106 to be under the new subtitle “Subtitle 31.
15 Virginia I. Jones Alzheimer’s Disease and Related Disorders Council”

18 Preamble

19 WHEREAS, There are more than 5.4 million Americans living with Alzheimer’s
20 disease and someone new is added to that number approximately every 68 seconds;
21 and

22 WHEREAS, There are an estimated 86,000 individuals in Maryland with
23 Alzheimer’s disease, and this number is expected to increase with the general aging of
24 the population; and

1 WHEREAS, Alzheimer's disease and related disorders are also associated with
2 a number of seriously disabling illnesses, including high blood pressure, high
3 cholesterol, and other cardiovascular diseases; and

4 WHEREAS, Individuals with Alzheimer's disease and related disorders live
5 many years after diagnosis and are at increased risk for high health care costs, social
6 isolation, and institutionalization; and

7 WHEREAS, Family members and caregivers of individuals with Alzheimer's
8 disease and related disorders commonly do not have access to services or knowledge of
9 the resources and information needed to provide effective and efficient care and
10 treatment of the disease; and

11 WHEREAS, The lack of access to and utilization of information results in less
12 effective treatment of Alzheimer's disease and related disorders and increases the
13 burden of care, leading to poorer outcomes for individuals living with the disease or
14 related disorders and their caregivers; and

15 WHEREAS, There is a need for more successful collaborative efforts in
16 Maryland, such as the annual Pythias A. and Virginia I. Jones African American
17 Community Forum on Memory Loss, created in the memory of Virginia I. Jones, a
18 Marylander committed to public service, who lived with the devastation of Alzheimer's
19 disease for approximately 10 years prior to diagnosis and for 17 years after diagnosis,
20 and her husband, who was also an Alzheimer's victim and her primary caregiver for
21 all of those 17 years; and

22 WHEREAS, The Forum brings together a public, private, and community
23 collaboration to inform the community and others about Alzheimer's disease and
24 related disorders, to support caregivers, to share information on services available,
25 and to bring the promise of research and opportunities to network with others who
26 share similar concerns; and

27 WHEREAS, Many Maryland agencies, associations, and institutions have
28 Alzheimer's disease and related disorders expertise but gaps remain in the
29 coordination of services and information relating to these chronic diseases; and

30 WHEREAS, The Governor established by Executive Order the Maryland
31 Alzheimer's Disease and Related Disorders Commission; and

32 WHEREAS, The Maryland Alzheimer's Disease and Related Disorders
33 Commission released its 2012 Maryland State Plan on Alzheimer's Disease and
34 Related Disorders which recommended the establishment of a permanent Alzheimer's
35 Disease and Related Disorders Council; now, therefore,

36 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
37 MARYLAND, That the Laws of Maryland read as follows:

1 (III) A REPRESENTATIVE OF THE ALZHEIMER'S
2 ASSOCIATION, GREATER MARYLAND CHAPTER;

3 (IV) A PHYSICIAN WHO CONDUCTS RESEARCH IN
4 ALZHEIMER'S DISEASE AND RELATED DISORDERS;

5 (V) A HEALTH PROFESSIONAL WITH EXPERTISE IN
6 ADDRESSING RACIAL AND ETHNIC HEALTH DISPARITIES;

7 (VI) A SOCIAL WORKER WITH EXPERIENCE WORKING WITH
8 INDIVIDUALS AND FAMILIES AFFECTED BY ALZHEIMER'S DISEASE AND
9 RELATED DISORDERS;

10 (VII) A PSYCHOLOGIST OR PSYCHIATRIST WITH EXPERTISE IN
11 ALZHEIMER'S DISEASE AND RELATED DISORDERS;

12 (VIII) A PHYSICIAN WITH EXPERIENCE IN END-OF-LIFE CARE
13 AND PAIN MANAGEMENT;

14 (IX) A REGISTERED NURSE WITH EXPERTISE IN
15 ALZHEIMER'S DISEASE AND RELATED DISORDERS;

16 (X) A LICENSED NURSE PRACTITIONER WITH EXPERTISE IN
17 END-OF-LIFE CARE AND PAIN MANAGEMENT;

18 (XI) A REPRESENTATIVE OF THE NURSING HOME AND
19 ASSISTED LIVING INDUSTRY;

20 (XII) AN INDIVIDUAL WITH EARLY-ONSET ALZHEIMER'S
21 DISEASE OR A RELATED DISORDER; AND

22 (XIII) TWO FAMILY CAREGIVERS, ONE OF WHOM IS A FAMILY
23 MEMBER OF AN INDIVIDUAL WITH ALZHEIMER'S DISEASE OR A RELATED
24 DISORDER.

26 (A) THE SECRETARY OF HEALTH AND MENTAL HYGIENE AND THE
27 SECRETARY OF AGING SHALL COCHAIR THE COUNCIL.

28 (B) A MEMBER OF THE COUNCIL:

1 **(1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE**
2 **COUNCIL; BUT**

3 **(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE**
4 **STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE**
5 **BUDGET.**

7 **(A) THE DEPARTMENT SHALL PROVIDE STAFF SUPPORT FOR THE**
8 **COUNCIL.**

9 **(B) THE DEPARTMENT MAY REQUEST STAFFING ASSISTANCE FROM**
10 **PUBLIC HEALTH ENTITIES WITH AN INTEREST IN THE DUTIES OF THE COUNCIL.**

11 **13-3106.**

12 **THE COUNCIL SHALL:**

13 **(1) CONTINUE THE WORK INITIATED BY THE MARYLAND**
14 **ALZHEIMER'S DISEASE AND RELATED DISORDERS COMMISSION, INCLUDING**
15 **THE DEVELOPMENT AND MONITORING OF THE 2012 MARYLAND STATE PLAN**
16 **ON ALZHEIMER'S DISEASE AND RELATED DISORDERS;**

17 **(2) INCLUDE IN THE STATE PLAN STRATEGIES AND ACTIONS**
18 **THAT:**

19 **(I) SUPPORT PREVENTION AND EARLY DETECTION OF**
20 **ALZHEIMER'S DISEASE AND RELATED DISORDERS, INCLUDING EARLY STAGE**
21 **IDENTIFICATION;**

22 **(II) ADDRESS CHRONIC DISEASE FACTORS CONTRIBUTING**
23 **TO DISPARITIES IN ALZHEIMER'S DISEASE; AND**

24 **(III) ENHANCE THE QUALITY OF CARE THROUGH:**

25 **1. BUILDING A WORKFORCE TRAINED TO CARE FOR**
26 **AND TREAT ALZHEIMER'S DISEASE AND RELATED DISORDERS;**

27 **2. EDUCATING PRIMARY CARE PROVIDERS ON BEST**
28 **PRACTICES; AND**

1 **3. PROMOTING ALZHEIMER'S DISEASE AND**
2 **RELATED DISORDERS CARE GUIDELINES AND PATIENT-CENTERED**
3 **APPROACHES IN ALL CARE SETTINGS;**

4 **(3) REVIEW STATE STATUTES, POLICIES, AND PROGRAMS TO**
5 **IMPROVE AND ENHANCE QUALITY OF LIFE AND SUPPORT AND SERVICES FOR**
6 **INDIVIDUALS LIVING WITH ALZHEIMER'S DISEASE AND RELATED DISORDERS**
7 **AND THEIR FAMILIES BY PROMOTING AND EXPANDING THE AVAILABILITY AND**
8 **ACCESSIBILITY OF HOME- AND COMMUNITY-BASED SUPPORT AND SERVICE**
9 **PROGRAMS;**

10 **(4) CONDUCT A PUBLIC EDUCATION CAMPAIGN ON:**

11 **(I) THE RISK FACTORS FOR DEMENTIA;**

12 **(II) THE IMPORTANCE OF SCREENING FOR DEMENTIA;**

13 **(III) THE AVAILABLE SUPPORT SERVICES AND RESOURCES;**

14 **(IV) THE NEED FOR ADVANCE PLANNING AND DECISION**
15 **MAKING; AND**

16 **(V) THE MARYLAND ACCESS POINT; AND**

17 **(5) IMPROVE DATA COLLECTION CAPACITY ON ALZHEIMER'S**
18 **DISEASE AND RELATED DISORDERS IN THE STATE TO BETTER TARGET**
19 **SUPPORT, SERVICES, AND NEEDS.**

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 October 1, 2013.
