## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Task Force to Study Housing and Supportive Services for Unaccompanied**  
3 **Homeless Youth**

4 FOR the purpose of establishing the Task Force to Study Housing and Supportive  
5 Services for Unaccompanied Homeless Youth; providing for the composition,  
6 chair, and staffing of the Task Force; prohibiting a member of the Task Force  
7 from receiving certain compensation, but authorizing the reimbursement of  
8 certain expenses; establishing the duties of the Task Force; requiring the Task  
9 Force to report its findings and recommendations to the Governor and the  
10 General Assembly on or before a certain date; providing for the termination of  
11 this Act; and generally relating to the Task Force to Study Housing and  
12 Supportive Services for Unaccompanied Homeless Youth.

13 Preamble

14 WHEREAS, Each year, over 1.6 million youth throughout the nation, and an  
15 increasing number of youth in Maryland, find themselves without stable housing and  
16 outside the care of a parent or guardian; and

17 WHEREAS, Many of these youth have become homeless and unaccompanied  
18 due to being rejected by their families because of their sexual orientation, gender  
19 identity, pregnancy, physical or sexual abuse, or severe conflict in the home, or  
20 because they have aged out of the foster care system without the skills and resources  
21 to support themselves; and

1 WHEREAS, Unaccompanied homeless youth are a largely invisible population,  
2 most of whom are “couch surfing” with friends and extended family, living on the  
3 streets, or squatting in vacant buildings; and

4 WHEREAS, Unaccompanied homeless youth are disproportionately likely to  
5 turn to delinquency, become victims of crime, commit suicide, suffer from physical and  
6 mental health impairments, engage in risky sexual behaviors, and drop out of school  
7 in order to survive on the street; and

8 WHEREAS, There is a lack of public and private sector programs and resources  
9 available to assist unaccompanied homeless youth, including a lack of shelter and  
10 permanent housing; case management; medical, mental health, and substance abuse  
11 treatment; education and job training; food and clothing; financial counseling; legal  
12 advice and representation; and other supportive services; and

13 WHEREAS, The foster care system is not adequately meeting the needs of  
14 many unaccompanied homeless youth, particularly those who do not come to the  
15 attention of child welfare agencies, those who are too old to enter foster care, those  
16 who have lived independently for so long that they are unlikely to form successful  
17 relationships with foster or adoptive parents, and those who have had particularly  
18 negative experiences while in foster care; and

19 WHEREAS, These youth are urgently in need of safe, secure, and stable  
20 housing as well as supportive services that will prevent them from becoming  
21 permanently homeless and, instead, set them on a path towards self-sufficiency; now,  
22 therefore,

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
24 MARYLAND, That:

25 (a) There is a Task Force to Study Housing and Supportive Services for  
26 Unaccompanied Homeless Youth.

27 (b) The Task Force consists of the following members:

28 (1) one member of the Senate ~~Budget and Taxation~~ Education, Health,  
29 and Environmental Affairs Committee, appointed by the President of the Senate;

30 (2) one member of the House Appropriations Committee, appointed by  
31 the Speaker of the House of Delegates;

32 (3) the Secretary of Housing and Community Development, or the  
33 Secretary’s designee;

34 (4) the Secretary of Human Resources, or the Secretary’s designee;

1 (5) the Secretary of Health and Mental Hygiene, or the Secretary's  
2 designee;

3 (6) the Secretary of Juvenile Services, or the Secretary's designee; and

4 (7) the following members, appointed by the Governor:

5 (i) one representative from the Governor's Office for Children;

6 (ii) two representatives from the State Department of  
7 Education;

8 ~~(ii)~~ (iii) two representatives from the Baltimore Homeless  
9 Youth Initiative, one of whom is a service provider and one of whom is a youth or  
10 young adult who has experienced homelessness;

11 ~~(iii)~~ (iv) two representatives from the Prince George's County  
12 Homeless Youth Work Group, one of whom is a service provider and one of whom is a  
13 youth or young adult who has experienced homelessness; and

14 ~~(iv)~~ (v) one representative from the Maryland Affordable  
15 Housing Coalition.

16 (c) The Task Force shall elect a chair from among its members.

17 (d) The Department of ~~Housing and Community Development~~ Health and  
18 Mental Hygiene shall provide staff for the Task Force.

19 (e) A member of the Task Force:

20 (1) may not receive compensation as a member of the Task Force; but

21 (2) is entitled to reimbursement for expenses under the Standard  
22 State Travel Regulations, as provided in the State budget.

23 (f) The Task Force shall:

24 (1) identify and study the unique needs of unaccompanied homeless  
25 youth between 13 and 25 years of age, and evaluate the public and private sector  
26 programs and resources currently available to meet those needs;

27 (2) collect and evaluate data on the unaccompanied homeless youth  
28 population in the State, including the number of unaccompanied homeless youth in  
29 each jurisdiction of the State;

30 (3) make recommendations on:

1 (i) legislation and policy initiatives to address the needs of  
2 unaccompanied homeless youth in the State; and

3 (ii) funding requirements and budgetary priorities to address  
4 the needs of unaccompanied homeless youth in the State; and

5 (4) make recommendations on any other relevant issues or  
6 considerations identified by the Task Force.

7 (g) On or before December 1, 2013, the Task Force shall report its findings  
8 and recommendations to the Governor and, in accordance with § 2-1246 of the State  
9 Government Article, the General Assembly.

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
11 June 1, 2013. It shall remain effective for a period of 1 year and 1 month and, at the  
12 end of June 30, 2014, with no further action required by the General Assembly, this  
13 Act shall be abrogated and of no further force and effect.
