## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2012 – Charles County – Indian**  
3 **Head Center for the Arts**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2012  
5 to include the Mayor and Town Council of the Town of Indian Head as a grantee  
6 for certain grants; providing for the purpose of a certain grant; and generally  
7 relating to amending the Maryland Consolidated Capital Bond Loan of 2012.

8 BY repealing and reenacting, with amendments,  
9 Chapter 444 of the Acts of the General Assembly of 2012  
10 Section 1(3) Item ZA02(AJ) and Item ZA03(AC)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
12 MARYLAND, That the Laws of Maryland read as follows:

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
15 MARYLAND, That:

17 (AJ) Indian Head Center for the Arts Renovation. Provide a grant  
18 equal to the lesser of (i) \$100,000 or (ii) the amount of the

21 **TOWN COUNCIL OF THE TOWN OF INDIAN HEAD FOR THE**  
22 **CONSTRUCTION, RENOVATION, AND CAPITAL EQUIPPING**  
23 **OF THE INDIAN HEAD CENTER FOR THE ARTS**, located in  
24 Indian Head. Notwithstanding Section 1(5) of this Act, the

4 ZA03 LOCAL HOUSE OF DELEGATES INITIATIVES

5 (AC) Indian Head Center for the Arts Renovation. Provide a grant  
 6 equal to the lesser of (i) \$70,000 or (ii) the amount of the  
 7 matching fund provided, to the Board of Directors of the  
 8 Indian Head Center for the Arts, Inc. **AND THE MAYOR AND**  
 9 **TOWN COUNCIL OF THE TOWN OF INDIAN HEAD** for the  
 10 construction, renovation, and capital equipping of the Indian  
 11 Head Center for the Arts, located in Indian Head.  
 12 Notwithstanding Section 1(5) of this Act, the matching fund  
 13 may consist of real property, in kind contributions, or funds  
 14 expended prior to the effective date of this Act (Charles  
 15 County) ..... 70,000

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 17 June 1, 2013.
