A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2010 – Baltimore City – Swann**
3 **Avenue Firehouse**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2010
5 to alter the deadline for the Mayor and City Council of the City of Baltimore to
6 present evidence of a certain matching fund and to encumber funds for a certain
7 grant; altering the name of a certain grantee; and generally relating to
8 amending the Maryland Consolidated Capital Bond Loan of 2010.

9 BY repealing and reenacting, with amendments,
10 Chapter 483 of the Acts of the General Assembly of 2010
11 Section 1(3) Item ZA03(S)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 Chapter 483 of the Acts of 2010

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That:

17 (3) ZA03 LOCAL HOUSE OF DELEGATES INITIATIVES

18 (S) Swann Avenue Firehouse. Provide a grant equal to the lesser
19 of (i) \$75,000 or (ii) the amount of the matching fund provided,
20 to the [Baltimore City Fire Department] **MAYOR AND CITY**
21 **COUNCIL OF THE CITY OF BALTIMORE** for the repair,
22 renovation, and capital equipping of the Swann Avenue
23 Firehouse, located in Baltimore City. Notwithstanding Section
24 1(5) of this Act, the matching fund may consist of real

1 property, in kind contributions, or funds expended prior to the
 2 effective date of this Act **AND THE GRANTEE HAS UNTIL**
 3 **JUNE 1, 2014, TO PRESENT EVIDENCE THAT A MATCHING**
 4 **FUND WILL BE PROVIDED. NOTWITHSTANDING SECTION**
 5 **1(7) OF THIS ACT, THIS GRANT MAY NOT TERMINATE**
 6 **BEFORE JUNE 1, 2014** (Baltimore City) 75,000

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 8 June 1, 2013.
