- 4 FOR the purpose of exempting certain Chesapeake Bay submerged land leases and 5 water column leases from a certain setback requirement; authorizing a submerged land lease or a water column lease of a riparian owner or a lawful 6 occupant of the riparian property to be located a certain minimum distance from a shallow-draft federal navigational channel in Herring Creek in St. Mary's County; making this Act an emergency measure; and generally relating to 10 submerged land leases and water column leases in the Chesapeake Bay Herring
