11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 12 MARYLAND, That the Laws of Maryland read as follows:

 15 (a) The generator of the University is used at
- 15 (a) The government of the University is vested in the Board of Regents.

16 (b) The Board of Regents consists of 15 members appointed by the Governor 17 with the advice and consent of the Senate.

- 18 (c) (1) One member of the Board of Regents shall be a student in good 19 academic standing at the University who:
- 20 (i) Is at least 18 years old; and
- 21 (ii) Has the qualifications required to be student body president.

$rac{6}{7}$	(d) (1) (I) Except for the student member, each member serves for a term of 6 years and until a successor is appointed and qualifies.
8 9	(II) The terms are staggered as required by the terms of the members serving on July 1, 1978.
10 11	(2) Except for the student member, [at least 8] THE members of the Board of Regents shall be residents of the State.
12 13	(3) A member appointed to fill a vacancy in an unexpired term serves only for the remainder of that term and until a successor is appointed and qualifies.
14	(e) Each member of the Board of Regents:
15	(1) Serves without compensation; and
