1 AN ACT concerning

2 **Queen Anne's County – Winery Special Event Permits – Farmers' Markets**

3 FOR the purpose of authorizing the Comptroller to issue a winery special event permit
4 to a Class 4 Maryland limited winery in Queen Anne's County for unlimited use
5 for a certain amount of time each week at certain farmers' markets in Queen
6 Anne's County; and generally relating to the issuance of a winery special event
7 permit for use at a farmers' market in Queen Anne's County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article 2B – Alcoholic Beverages**

2 (u) (1) The Office of the Comptroller may issue a winery special event
3 permit to a licensed Class 4 Maryland limited winery, provided that:

4 (i) Except as provided in paragraphs (6), (7), (8), (9), (10), (11),
5 (12), (13), [and] (14), AND (15) of this subsection, no more than 12 winery special
6 event permits are issued to the Class 4 Maryland limited winery in any given calendar
7 year;

8 (ii) The permit does not exceed 3 consecutive days; and

9 (iii) Except as provided in paragraphs (6), (7), (8), (9), (10), (11),
10 (12), (13), [and] (14), AND (15) of this subsection, no more than three winery special
11 event permits are issued in any calendar year to any given limited winery for use in
12 the same political subdivision.

13 **(15) IN ADDITION TO THE WINERY SPECIAL EVENT PERMITS THAT**
14 **MAY BE ISSUED UNDER PARAGRAPH (1)(I) AND (III) OF THIS SUBSECTION, A**
15 **CLASS 4 MARYLAND LIMITED WINERY MAY BE ISSUED A WINERY SPECIAL**
16 **EVENT PERMIT FOR UNLIMITED USE FOR 1 DAY EACH WEEK AT A FARMERS'**
17 **MARKET IN QUEEN ANNE'S COUNTY THAT IS LISTED ON THE FARMERS'**
18 **MARKET DIRECTORY OF THE MARYLAND DEPARTMENT OF AGRICULTURE.**

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
20 July 1, 2013.
