#### 1 AN ACT concerning

# Baltimore County - Commission to Study the Establishment of a Truancy Reduction Program

- 4 FOR the purpose of establishing the Commission to Study the Establishment of a  $\mathbf{5}$ Truancy Reduction Program in Baltimore County; providing for the 6 composition, chair, and staffing of the Commission; requiring the Maryland 7 Judicial Conference to designate a representative to act in an advisory capacity 8 to the Commission; prohibiting a member of the Commission from receiving 9 certain compensation, but authorizing the reimbursement of certain expenses; 10 requiring the Commission to study and make recommendations regarding certain matters; requiring the Commission to report its findings and 11 12 recommendations to the Baltimore County Executive, the Superintendent of the Baltimore County Public Schools, the Baltimore County Board of Education, 13 certain committees of the General Assembly, and the Chair of the Baltimore 14County Senators and the Chair of the Baltimore County Delegation of the 1516 General Assembly on or before a certain date; providing for the termination of 17this Act; and generally relating to the Commission to Study the Establishment of a Truancy Reduction Program in Baltimore County. 18

1 There is a Commission to Study the Establishment of a Truancy (a)  $\mathbf{2}$ Reduction Program in Baltimore County. 3 (b) The Commission consists of: 4 (1)the Baltimore County Executive, or the County Executive's  $\mathbf{5}$ designee; 6 the Baltimore County State's Attorney, or the State's Attorney's (2)7 designee; 8 (3)the Director of the Baltimore County Department of Social 9 Services, or the Director's designee; 10 a designee of the Secretary of Juvenile Services who works in (4)11 Baltimore County; and 12(5)the following members, appointed by the Baltimore County Executive, in consultation with the Chair of the Baltimore County Senators and the 13Chair of the Baltimore County Delegation of the General Assembly: 14one administrative judge of the Baltimore County Circuit 15(i) Court; 1617one employee of the Baltimore County Public Schools who  $\frac{(ii)}{(ii)}$ works in Pupil Personnel Services; 18 19one employee of the Baltimore County Public Schools <del>(iii)</del> (ii) 20who works as a court liaison; 21(iiii) one employee of the Baltimore County Public Schools 22who works as a school counselor: 23one employee of the Baltimore County Public Schools <del>(v)</del> (iv) 24who works as a high school principal; 25 $\frac{(vi)}{(v)}$ one employee of the Baltimore County Public Schools 26who works as an Assistant Superintendent or an Executive Director; and 27<del>(vii)</del> (vi) one representative of the Teachers Association of 28Baltimore County. 29The Maryland Judicial Conference shall designate a representative to act (c)30 in an advisory capacity to the Commission.

23 24 25 26 27 28 29 30	(g) (h) On or before December 15, 2013, the Commission shall report its findings and recommendations on the feasibility of establishing a Truancy Reduction Program in Baltimore County to the Baltimore County Executive, the Superintendent of the Baltimore County Public Schools, the Baltimore County Board of Education, and, in accordance with § 2–1246 of the State Government Article, the Senate Education, Health, and Environmental Affairs Committee, the House Ways and Means Committee, and the Chair of the Baltimore County Senators and the Chair of the Baltimore County Delegation of the General Assembly.
