FOR the purpose of altering the definition of "raw agricultural product" to include 5 6 honey and herb mixtures and flavored honey; exempting a person that 7 manufactures, processes, and sells honey and herb mixtures or flavored honey 8 from the requirement to obtain an on-farm home processing facility license or 9 permit requiring the Department of Health and Mental Hygiene to study whether it is necessary to continue to require a certain license and permit for 10 the sale, manufacturing, and processing of honey and herb mixtures, including 11 flavored honey; requiring the Department to report its findings and 12 recommendations to the General Assembly on or before a certain date; providing 13 for the termination of this Act; and generally relating to a study on license and 14 permit requirements for the sale, manufacturing, and processing of honey and 15 herb mixtures and flavored honey. 16
