## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2011 – Prince George’s County**  
3 **– Capitol Heights Seat Pleasant Boys and Girls Club Initiative**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2011  
5 to alter the deadline for a certain grantee to present evidence of certain  
6 matching funds; providing that certain grants may not terminate before a  
7 certain date; and generally relating to amending the Maryland Consolidated  
8 Capital Bond Loan of 2011.

9 BY repealing and reenacting, with amendments,  
10 Chapter 396 of the Acts of the General Assembly of 2011  
11 Section 1(3) Item ZA02(BJ) and Item ZA03(AW)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
13 MARYLAND, That the Laws of Maryland read as follows:

### 14 **Chapter 396 of the Acts of 2011**

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
16 MARYLAND, That:

18 (BJ) Capitol Heights Seat Pleasant Boys and Girls Club Initiative.  
19 Provide a grant equal to the lesser of (i) \$25,000 or (ii) the  
20 amount of the matching fund provided, to the Board of  
21 Directors of the Prince George’s County Boys and Girls Club,  
22 Inc. for the acquisition, planning, design, construction,  
23 renovation, and capital equipping of the scoreboard, signs,  
24 and stands, located in Prince George’s County.  
25 Notwithstanding Section 1(5) of this Act, the matching fund

 16 and stands for the Capitol Heights and Seat Pleasant Boys  
 17 and Girls Club field, located in Prince George’s County.  
 18 Notwithstanding Section 1(5) of this Act, the matching fund  
 19 may consist of real property, in kind contributions, or funds  
 20 expended prior to the effective date of this Act.
