On page 1, in line 12, after "needs;" insert "providing for the confidentiality of certain documents and information under certain provisions of law; providing that certain information and documents are not subject to discovery or admissible in certain actions;"; and in line 26, after "statement;" insert "requiring certain persons to file an annual enterprise risk report that includes certain information; authorizing the sharing of certain information in an enterprise risk report under certain circumstances;".

On page 2, in line 20, strike "a"; in the same line, strike "penalty" and substitute "<u>violations subject to certain penalties</u>"; and in line 31, after "Section" insert "2-209(g)(1)."

AMENDMENT NO. 2

On page 3, before line 1, insert:

"2–209.

(g) (1) This subsection applies only to a document, material, or information other than an adopted examination report that:

(i) is in the control or possession of the Commissioner; and

(ii) is obtained or generated during an analysis or examination conducted under § 2–205 or § 2–206 of this subtitle, **TITLE 7 OF THIS ARTICLE**, or § 23–103, § 15–10B–19, or § 15–10B–20 of this article.".
