AMENDMENT NO. 1

On page 1, in line 6, after "circumstances;" insert "<u>exempting a certain food</u> retailer, food service facility, or food service supplier from the prohibition against possessing, selling, offering for sale, trading, or distributing a shark fin under certain circumstances;".

AMENDMENT NO. 2

On page 1, in line 20, after "(2)" insert "<u>"FOOD RETAILER" MEANS A</u> <u>GROCERY STORE, MARKET, OR SIMILAR ESTABLISHMENT THAT SELLS FOOD AT</u> <u>RETAIL TO THE GENERAL PUBLIC FOR OFF-PREMISES CONSUMPTION.</u>

(3) <u>"Food service facility" has the meaning stated in §</u> 21-301 of the Health – General Article.

(4) <u>"FOOD SERVICE SUPPLIER" MEANS AN ENTITY THAT SELLS</u> FOOD AT WHOLESALE TO A FOOD SERVICE FACILITY OR FOOD RETAILER.
