(V) EACH EXECUTIVE ORDER OR PROCLAMATION THAT DECLARES OR TERMINATES A FISCAL EMERGENCY SHALL INDICATE:

(I) <u>THE NATURE OF THE EMERGENCY; AND</u>

(II) <u>THE CONDITIONS THAT HAVE BROUGHT ABOUT</u> <u>THE FISCAL EMERGENCY OR THAT MAKE POSSIBLE THE TERMINATION OF THE</u> FISCAL EMERGENCY.
