AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and M. Washington" and substitute "M. Washington, Hammen, Pendergrass, Costa, Donoghue, Elliott, Frank, Hubbard, Kach, Kipke, Krebs, Morhaim, Murphy, Pena-Melnyk, Ready, Reznik, Tarrant, and V. Turner"; strike in its entirety line 2 and substitute "Telemedicine Task Force—Maryland Health Care Commission"; and strike beginning with "establishing" in line 3 down through "Care" in line 10 and substitute "declaring the intent of the General Assembly that the Maryland Health Care Commission, in conjunction with the Maryland Health Quality and Cost Council, continue to study the use of telehealth throughout the State through the Telemedicine Task Force; requiring the Task Force to consist of certain advisory groups and undertake certain activities; and requiring the Commission, on or before certain dates, to submit certain reports of the Task Force to the Governor and certain legislative committees".

AMENDMENT NO. 2

On pages 1 through 4, strike beginning with "(a)" in line 13 on page 1 down through the period in line 27 on page 4 and substitute:

- "(a) It is the intent of the General Assembly that the Maryland Health Care Commission, in conjunction with the Maryland Health Quality and Cost Council, continue to study the use of telehealth throughout the State through the Telemedicine Task Force.
 - (b) The Task Force shall:
 - (1) consist of three existing advisory groups:
 - (i) the clinical advisory group;

- (c) The Maryland Health Care Commission shall submit to the Governor and, in accordance with § 2-1246 of the State Government Article, the Senate Finance Committee and the House Health and Government Operations Committee:
- (1) on or before January 1, 2014, an interim report of the Task Force findings and recommendations; and
- (2) on or before December 1, 2014, a final report of the Task Force findings and recommendations.".

On page 4, in line 29, strike "October" and substitute "July"; in the same line, strike "1 year and 8 months" and substitute "2 years"; and in line 30, strike "May 31" and substitute "June 30".
