AMENDMENT NO. 1

On page 1, in lines 2 and 3, strike "Without Supervision" and substitute "<u>at a</u> <u>Community-Based Health Fair</u>"; and in line 5, strike "in any setting;" and substitute "<u>without compensation at certain community-based health fairs; requiring the Board</u> <u>of Dental Examiners, in consultation with the Department of Health and Mental</u> <u>Hygiene's Office of Oral Health, to develop a certain form; requiring a certain dental</u> <u>hygienist to complete and submit a certain form to the Office of Oral Health under</u> <u>certain circumstances; defining a certain term;</u>".

AMENDMENT NO. 2

On page 1, after line 15, insert:

"(A) IN THIS SECTION, "COMMUNITY-BASED HEALTH FAIR" MEANS A HEALTH SERVICE EVENT THAT OFFERS PRIMARY HEALTH CARE SERVICES TO AN INDIVIDUAL FOR FREE OR USING A SLIDING FEE SCHEDULE THAT IS SPONSORED BY:

(1) THE FEDERAL, THE STATE, OR A LOCAL GOVERNMENT;

(2) <u>A NONPROFIT ORGANIZATION THAT IS EXEMPT FROM</u> TAXATION UNDER § 501(C)(3) OF THE INTERNAL REVENUE CODE; OR

(3) <u>A NONPROFIT COMMUNITY ORGANIZATION THAT HAS THE</u> STATED PURPOSE OF PROVIDING HEALTH SERVICES TO THE DISADVANTAGED.";

in line 16, before "NOTWITHSTANDING" insert "(B)"; in line 17, after "PROVIDE" insert "WITHOUT COMPENSATION"; in line 18, strike "IN ANY SETTING" and

(Over)

substitute "<u>AT A COMMUNITY-BASED HEALTH FAIR</u>"; in line 19, strike "ORAL HEALTH AND WELLNESS ASSESSMENTS" and substitute "<u>A PRELIMINARY DENTAL</u> <u>EXAMINATION, INCLUDING CHARTING ANY CAVITIES, RESTORATIONS, OR</u> <u>MISSING TEETH</u>"; in line 20, strike "DENTAL HYGIENE" and substitute "<u>ORAL</u> <u>HEALTH</u>"; and in line 21, strike "A REFERRAL TO A DENTAL HOME" and substitute "<u>TAKING BLOOD PRESSURE, PULSE RATE, RESPIRATION RATE, HEIGHT, AND</u> <u>WEIGHT</u>".

AMENDMENT NO. 3

On page 2, in line 1, strike "FLUORIDE VARNISH TREATMENTS" and substitute "<u>REFERRALS TO A DENTAL HOME, INCLUDING PROVIDING A PATIENT</u> <u>WITH A LIST OF CLINICAL PUBLIC HEALTH FACILITIES</u>"; and after line 1, insert:

"(C) (1) THE BOARD, IN CONSULTATION WITH THE DEPARTMENT'S OFFICE OF ORAL HEALTH, SHALL DEVELOP A STANDARD FORM TO BE USED BY A DENTAL HYGIENIST WHO PERFORMS THE SERVICES AUTHORIZED UNDER THIS SECTION AT A COMMUNITY-BASED HEALTH FAIR.

(2) <u>A DENTAL HYGIENIST WHO PERFORMS SERVICES IN</u> <u>ACCORDANCE WITH THIS SECTION SHALL:</u>

(I) FILL OUT THE FORM REQUIRED UNDER PARAGRAPH (1) OF THIS SUBSECTION FOR EACH PATIENT WHO RECEIVED SERVICES FROM THE DENTAL HYGIENIST; AND

(II) SUBMIT THE COMPLETED FORM TO THE OFFICE OF ORAL HEALTH.".
