BE IT ENACTED BY THE GENERAL ASSEMBLY OF 11 12 MARYLAND, That the Laws of Maryland read as follows: Article - Tax - General 13 10-105.14 15 (b) The State income tax rate for a corporation is [8.25%] **6**% of Maryland 16 taxable income. SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 17 18 July 1, 2014, and shall be applicable to all taxable years beginning after December 31, 19 2013.
