2 **Juvenile Law – Truancy Reduction Pilot Program – Kent County**

3 FOR the purpose of authorizing the Circuit Administrative Judge of the Second
4 Circuit to establish a Truancy Reduction Pilot Program in the juvenile court in
5 Kent County; making certain provisions relating to a Truancy Reduction Pilot
6 Program in certain counties applicable to Kent County; and generally relating
7 to a Truancy Reduction Pilot Program in Kent County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article – Courts and Judicial Proceedings**

2 This subtitle applies only:

3 (1) In a county in which the circuit administrative judge has
4 established a Truancy Reduction Pilot Program under § 3-8C-02 of this subtitle; and

5 (2) To the extent that funds are provided in an annual State budget
6 for a Truancy Reduction Pilot Program.

7 3-8C-02.

8 (a) (1) The Circuit Administrative Judge of the First Circuit may
9 establish a Truancy Reduction Pilot Program in one or more of the juvenile courts in
10 Dorchester County, Somerset County, Wicomico County, and Worcester County.

11 (2) The Circuit Administrative Judge of the Second Circuit may
12 establish a Truancy Reduction Pilot Program in the juvenile [court] **COURTS** in **KENT**
13 **COUNTY AND** Talbot County.

14 (3) The Circuit Administrative Judge of the Third Circuit may
15 establish a Truancy Reduction Pilot Program in the juvenile court in Harford County.

16 (4) The Circuit Administrative Judge of the Seventh Circuit may
17 establish a Truancy Reduction Pilot Program in the juvenile court in Prince George's
18 County.

19 (b) After consultation with the administrative judges of the first, second,
20 third, and seventh circuits, the Chief Judge of the Court of Appeals may accept a gift
21 or grant to implement the pilot programs in each respective circuit.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 June 1, 2014.
