3 (b) A LICENSED TREE EXPERT MAY NOT SUPERVISE MORE THAN ONE 4 COMPANY THAT PROVIDES TREE EXPERT SERVICES.

5 (C) If the owner of a tree employs any person to engage in the practice of a 6 "licensed tree expert" as provided in § 5–415 of this subtitle, the owner is not subject to 7 this penalty.

8 [(c)] (D) A person may not advertise that the person can provide tree 9 services, including treatment, care, or removal of trees, unless the advertisement 10 includes:

11 (1) The license number of the licensed tree expert advertising tree 12 services in one of the following forms: "Licensed Tree Expert No.___" or "L.T.E. 13 No.__"; or

14 (2) A statement that all tree services are limited to trees 20 feet tall or 15 less.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect17 October 1, 2014.
