A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2011 – Prince George’s County**
3 **– Riverdale Park Town Hall Expansion**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2011
5 to provide that certain grants for the Riverdale Park Town Hall Expansion may
6 not terminate before a certain date; and generally relating to an amendment to
7 the Maryland Consolidated Capital Bond Loan of 2011.

8 BY repealing and reenacting, with amendments,
9 Chapter 396 of the Acts of the General Assembly of 2011
10 Section 1(3) Item ZA02(BO) and Item ZA03(BE)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

19 fund provided, to the Mayor and Town Council of the Town of

21 the Riverdale Park Town Hall, located in Riverdale Park.

22 **NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THIS**
23 **GRANT MAY NOT TERMINATE BEFORE JUNE 1, 2015**
