## Criminal Procedure - Vulnerable Adult Abuse Registry

3 FOR the purpose of establishing a vulnerable adult abuse registry; requiring the 4 Department of Health and Mental Hygiene to establish and maintain a registry 5 containing the names of certain individuals; requiring that names and 6 information contained in the registry be available for public inspection; 7 authorizing the Department to discharge certain responsibilities in a certain 8 manner; requiring a State agency that makes a certain finding to notify the 9 Department in a certain manner; requiring the State's Attorney to report a conviction of an individual for a certain crime to the Department; requiring the 10 Department to enter the names of certain individuals and information in the 11 12 registry in certain circumstances; requiring the Department to notify an 13 individual of inclusion in the registry in a certain manner; authorizing the 14 individual to challenge the accuracy of a certain report in a certain manner; requiring the removal of a certain individual's name from the registry under 15 16 certain circumstances; authorizing a State agency to recommend the removal of 17 an individual's name from the registry in certain circumstances; authorizing a certain appeal; requiring a certain State agency to consult the registry prior to 18 hiring an employee or using a volunteer; prohibiting a certain agency from 19 20 hiring or otherwise using the services of an individual who is listed in the 21 registry; providing immunity for certain persons; defining certain terms; and 22 generally relating to abuse of vulnerable adults.

"MISAPPROPRIATION" MEANS A TAKING, POSSESSION, OR USE OF 19 THE PROPERTY OF A VULNERABLE ADULT, THE ELEMENTS OF WHICH 2021CONSTITUTE A CRIMINAL OFFENSE INVOLVING THE PROPERTY OR CONSTITUTE
- (E) "OFFENSE AGAINST A VULNERABLE ADULT" MEANS AN ACT THAT
  CONSTITUTES ABUSE, NEGLECT, OR MISAPPROPRIATION OR EXPLOITATION OF
  THE PROPERTY OF A VULNERABLE ADULT, EVEN IF THE ACT DOES NOT
  CONSTITUTE A CRIMINAL ACT OR A CRIME, THE ELEMENTS OF WHICH
  CONSTITUTE ABUSE, NEGLECT, OR MISAPPROPRIATION OR EXPLOITATION OF

A VIOLATION OF A FIDUCIARY DUTY OF A CARETAKER OF A VULNERABLE ADULT.

- (G) "REGISTRY" MEANS THE VULNERABLE ADULT ABUSE REGISTRY 1 2 ESTABLISHED AND MAINTAINED BY THE DEPARTMENT OF HEALTH AND 3 MENTAL HYGIENE.
- "Vulnerable adult" has the meaning stated in § 3-604 of 4 THE CRIMINAL LAW ARTICLE. 5

- 9 A CRIME COMMITTED IN A FEDERAL, STATE, OR FOREIGN JURISDICTION THAT, IF COMMITTED IN THIS STATE, WOULD CONSTITUTE ONE 10 11 OF THE CRIMES LISTED IN ITEM (1) OF THIS SUBSECTION.

- 10 ADMINISTRATIVE ORDER, A JUDICIAL ORDER, OR ANY OTHER EVIDENCE
- 11 INDICATING THAT THE AGENCY HAS AFFORDED THE INDIVIDUAL AN
- 12 OPPORTUNITY FOR AN ADMINISTRATIVE DUE PROCESS HEARING IN
- 13 ACCORDANCE WITH THE REQUIREMENTS OF TITLE 10, SUBTITLE 2 OF THE

- 2. THE INDIVIDUAL'S LAST KNOWN MAILING

- 3. THE DEFINITION OF ABUSE, NEGLECT, OR
- 18 MISAPPROPRIATION OR EXPLOITATION OF PROPERTY THAT WAS USED BY THE
- 19 AGENCY IN MAKING THE FINDINGS OF ABUSE; AND
- 20 4. OTHER INFORMATION THAT THE DEPARTMENT OF
- 21 HEALTH AND MENTAL HYGIENE MAY DETERMINE IS NECESSARY TO
- 22 ADEQUATELY IDENTIFY THE INDIVIDUAL FOR PURPOSES OF ADMINISTRATIVE
- 23 HEARINGS PROVIDED BY THIS SUBTITLE OR TO ADEQUATELY IDENTIFY THE
- 24 INDIVIDUAL WHEN INQUIRY TO THE REGISTRY IS MADE.
- 25 (II) THIS SUBTITLE DOES NOT REQUIRE A STATE AGENCY
- 26 TO ESTABLISH NEW PROCEDURES OR TO MODIFY EXISTING PROCEDURES THE
- 27 AGENCY MAY USE FOR THE PROVISION OF DUE PROCESS TO THE INDIVIDUAL.
- 28 (B) ON CONVICTION OF AN INDIVIDUAL FOR A VULNERABLE ADULT
- 29 ABUSE CRIME, THE STATE'S ATTORNEY SHALL REPORT THE INDIVIDUAL'S
- 30 NAME TO THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE.
- 31 (C) ON RECEIVING A NOTIFICATION DESCRIBED IN SUBSECTION (A) OR
- 32 (B) OF THIS SECTION, THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE

- 4 ABUSE, NEGLECT, OR MISAPPROPRIATION OR EXPLOITATION OF PROPERTY
- 5 SUPPLIED BY THE REPORTING AGENCY OR COURT.
- 6 (D) (1) ON ENTRY OF THE INFORMATION UNDER SUBSECTION (C) OF
- 7 THIS SECTION, THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE SHALL
- 8 NOTIFY THE INDIVIDUAL, AT THE INDIVIDUAL'S LAST KNOWN MAILING
- 9 ADDRESS, OF THE INDIVIDUAL'S INCLUSION IN THE REGISTRY.
- 10 (2) (I) THE INDIVIDUAL MAY CHALLENGE THE ACCURACY OF
- 11 THE REPORT THAT THE FINDING OR CONVICTION OCCURRED OR OF A FACT
- 12 ISSUE RELATED TO THE CORRECT IDENTITY OF THE INDIVIDUAL.
- 13 (II) IF THE INDIVIDUAL MAKES A CHALLENGE WITHIN 30
- 14 DAYS OF NOTIFICATION OF INCLUSION OF THE INDIVIDUAL'S NAME IN THE
- 15 REGISTRY, THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE SHALL
- 16 AFFORD THE INDIVIDUAL AN OPPORTUNITY FOR A HEARING ON THE MATTER
- 17 THAT COMPLIES WITH THE REQUIREMENTS OF DUE PROCESS AND TITLE 10,
- 18 SUBTITLE 2 OF THE STATE GOVERNMENT ARTICLE.
- 19 (E) AN INDIVIDUAL'S NAME IMMEDIATELY SHALL BE REMOVED FROM
- 20 THE REGISTRY IF:
- 21 (1) AFTER A HEARING, THE DEPARTMENT OF HEALTH AND
- 22 MENTAL HYGIENE DETERMINES THAT THE FINDINGS OR CONVICTION NEVER
- 23 OCCURRED; OR
- 24 (2) AT THE FINAL STEP TAKEN IN AN APPELLATE PROCESS, A
- 25 REPORTED CONVICTION, AN EMERGENCY ORDER, OR AN ADMINISTRATIVE
- 26 HEARING RESULT IS REVERSED.
- 27 (F) (1) A STATE AGENCY THAT HAS PLACED AN INDIVIDUAL'S NAME
- 28 IN THE REGISTRY IN ACCORDANCE WITH THIS SUBTITLE MAY RECOMMEND TO
- 29 THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE THE REMOVAL OF THE
- 30 INDIVIDUAL'S NAME IF:
- 31 (I) THE AGENCY FINDS THAT THE PLACEMENT OF THE
- 32 INDIVIDUAL'S NAME IN THE REGISTRY WAS IN ERROR; OR

- 1 (II) AN ADVISORY GROUP CONVENED BY THE AGENCY
- 2 DETERMINES, BASED ON EVIDENCE PRESENTED TO THE GROUP, THAT REMOVAL
- 3 OF THE INDIVIDUAL'S NAME FROM THE REGISTRY CLEARLY IS WARRANTED AND
- 4 RECOMMENDS IN WRITING TO THE AGENCY A WAIVER AND REMOVAL OF THE
- 5 INDIVIDUAL'S NAME FROM THE REGISTRY.
- 6 (2) AN ADVISORY GROUP UNDER PARAGRAPH (1)(II) OF THIS 7 SUBSECTION SHALL BE COMPOSED OF INDIVIDUALS:
- 8 (I) WITH EXPERIENCE IN THE SUBJECT MATTER AREAS OF
- 9 THE AGENCY'S WORK; OR
- 10 (II) WHO ARE QUALIFIED BY EXPERIENCE OR EDUCATION,
- 11 AS DETERMINED BY THE AGENCY, TO PROVIDE RECOMMENDATIONS TO THE
- 12 AGENCY REGARDING AN INDIVIDUAL'S LIKELIHOOD OF COMMITTING FURTHER
- 13 ACTS OR OMISSIONS THAT LED TO THE INDIVIDUAL'S NAME BEING PLACED IN
- 14 THE REGISTRY.
- 15 (3) THE FINAL DECISION REGARDING THE RECOMMENDATION
- 16 FOR REMOVAL OF AN INDIVIDUAL'S NAME FROM THE REGISTRY SHALL BE MADE
- 17 BY THE STATE AGENCY. THE RECOMMENDATION SHALL BE IN WRITING, SHALL
- 18 GIVE THE AGENCY'S REASONS FOR THE DECISION, AND SHALL BE SENT TO THE
- 19 INDIVIDUAL SEEKING THE WAIVER.
- 20 (4) If the decision is to remove the individual's name
- 21 FROM THE REGISTRY, THE RECOMMENDATION SHALL BE SENT TO THE
- 22 DEPARTMENT OF HEALTH AND MENTAL HYGIENE AND THE INDIVIDUAL'S
- 23 NAME SHALL BE REMOVED BY THE DEPARTMENT.
- 24 (5) (I) AN INDIVIDUAL SEEKING A WAIVER WHO IS
- 25 DISSATISFIED WITH THE DETERMINATION MADE BY THE STATE AGENCY MAY
- 26 APPEAL.
- 27 (II) THE APPEAL SHALL BE CONDUCTED AS A CONTESTED
- 28 CASE HEARING IN ACCORDANCE WITH TITLE 10, SUBTITLE 2 OF THE STATE
- 29 GOVERNMENT ARTICLE.
- 30 (6) THE DECISION AND THE WRITTEN RECOMMENDATIONS OF
- 31 THE ADVISORY GROUP AND THE STATE AGENCY SHALL BE OPEN FOR PUBLIC
- 32 INSPECTION.

- 1 (A) A STATE AGENCY THAT PROVIDES INSTITUTIONAL OR IN-HOME 2 SERVICES TO VULNERABLE ADULTS SHALL CONSULT THE REGISTRY PRIOR TO 3 HIRING AN EMPLOYEE OR USING A VOLUNTEER.
- 4 (B) A STATE AGENCY DESCRIBED IN SUBSECTION (A) OF THIS SECTION
  5 MAY NOT HIRE OR OTHERWISE USE THE SERVICES OF AN INDIVIDUAL WHO IS
  6 LISTED ON THE REGISTRY.

- 8 (A) UNLESS THE INDIVIDUAL ACTED IN BAD FAITH OR WITH MALICIOUS
  9 PURPOSE, AN INDIVIDUAL WHO SUBMITS AN ALLEGATION OF ABUSE, NEGLECT,
  10 OR MISAPPROPRIATION OR EXPLOITATION OF PROPERTY TO THE DEPARTMENT
  11 OF HEALTH AND MENTAL HYGIENE FOR INCLUSION IN THE REGISTRY OR WHO
  12 TESTIFIES IN AN ADMINISTRATIVE OR JUDICIAL PROCEEDING ARISING FROM
  13 THE ALLEGATION IS IMMUNE FROM CIVIL OR CRIMINAL LIABILITY FOR MAKING
  14 THE REPORT AND FOR TESTIFYING, EXCEPT FOR LIABILITY FOR PERJURY.
- 15 **(B)** A PERSON THAT DECLINES TO EMPLOY OR OTHERWISE USE THE SERVICES OF AN INDIVIDUAL LISTED IN THE REGISTRY OR THAT TERMINATES THE INDIVIDUAL IS IMMUNE FROM SUIT BY OR ON BEHALF OF THAT INDIVIDUAL.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2014.
