## A BILL ENTITLED

1 AN ACT concerning

### 2 Northeastern Maryland Higher Education Advisory Board – Revisions

- 3 FOR the purpose of altering the membership of the Northeastern Maryland Higher 4 Education Advisory Board; repealing a provision that requires the Board to  $\mathbf{5}$ ensure that certain academic programs and policies of the University Center 6 and sites are in compliance with certain policies of the Maryland Higher 7 Education Commission; authorizing the Board to make certain agreements with 8 certain entities under certain circumstances; altering certain definitions; 9 making stylistic changes; and generally relating to the Northeastern Maryland Higher Education Advisory Board. 10

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 17 MARYLAND, That the Laws of Maryland read as follows:
- 18Article Education1924–901.20(a)(a)In this subtitle the following terms have the meanings indicated.
- (b) "Board" means the Northeast Maryland Higher Education AdvisoryBoard.

"Center" means the [Higher Education and Conference] UNIVERSITY 1 (c)  $\mathbf{2}$ Center at HEAT. 3 (d) "Commission" means the Maryland Higher Education Commission. 4 "Site" means a LOCATION WHERE A 4-year institution of higher (e)  $\mathbf{5}$ education [that] offers Commission-approved undergraduate and graduate programs in Cecil County [and] OR Harford County [and is affiliated with the Center]. 6 7 24 - 903.The Board consists of the following voting members: 8 (a) 9 One representative of each of the 4-year institutions of higher (1)10 education offering a Commission-approved program at the Center [and] OR at a site, appointed by the institution; and 11 12The following 10 representatives, appointed in accordance with (2)13the bylaws of the Board: 14(i) Three representatives of regional businesses, industries, or corporations; 1516 One representative of the Cecil County Office of Economic (ii) 17**Development**; One representative of the Harford County Office of Economic 18 (iii) 19Development; 20One representative of Cecil College; (iv) 21One representative of Harford Community College; (v) 22(vi) One representative of the Northeast Maryland University 23Research Park; and 24(vii) Two representatives chosen from the community at large. 25Each member serves for a term of 3 years and until a successor is (b)(1)26appointed and qualifies. 27(2)A member may not serve more than two full consecutive terms. 28A member appointed to fill a vacancy in an unexpired term serves (3)29only for the remainder of that term and until a successor is appointed and qualifies.

19 20 21	(a) In addition to the other powers expressly granted and duties imposed by this title, and subject to the authority of the Commission, the Board has only the powers and duties set forth in this section.

Assist with the marketing and promotion of programs offered at 1 (5) $\mathbf{2}$ the Center and sites: 3 (6)Facilitate interactions among the business, nonprofit, education, 4 and military communities: Keep separate records and minutes; and  $\mathbf{5}$ (7)6 Adopt reasonable rules, regulations, or bylaws to carry out the (8)7 provisions of this subtitle. 8 (c)The Board shall ensure that all academic programs and policies of the 9 Center and sites are in compliance with the policies of and approved by the 10 Commission. 11 The Board may apply, accept, and expend any gift, appropriation, or (d) 12grant from the State, county, or federal government or any other person. 13[(e)] **(D)** The Board may make agreements with the federal, State, or a county government or any other person, if it considers the agreement advisable for the 14[operation of the Center] SUPPORT OF HIGHER EDUCATION. 15[(f)] **(E)** 16 The Board may adopt a corporate seal. 17[(g)] **(F)** In addition to other reports that may be required by the Commission, the Board shall: 18 19(1)Keep records that are consistent with sound business practices and 20accounting records using generally accepted accounting principles; 21(2)Cause an audit by an independent certified public accountant to be 22made of the accounts and transactions of the Center at the conclusion of each fiscal 23year; and 24(3)For any State money, be subject to an audit by the Office of 25Legislative Audits, in accordance with §§ 2-1220 through 2-1227 of the State Government Article. 2627SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 28July 1, 2014.
