## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2012 – Montgomery County –**  
3 **Woodlawn Barn Visitor’s Center**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2012  
5 to alter the grantee of certain grants for the Woodlawn Barn Visitor’s Center;  
6 altering the requirement to provide a certain matching fund; extending the  
7 deadline for certain grantees to present evidence of a certain matching fund;  
8 providing that certain grants may not terminate before a certain date; and  
9 generally relating to amending the Maryland Consolidated Capital Bond Loan  
10 of 2012.

11 BY repealing and reenacting, with amendments,  
12 Chapter 444 of the Acts of the General Assembly of 2012, as amended by  
13 Chapter 430 of the Acts of the General Assembly of 2013  
14 Section 1(3) Item ZA02(BB) and Item ZA03(AO)

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
16 MARYLAND, That the Laws of Maryland read as follows:

18 **2013**

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
20 MARYLAND, That:

23 (BB) Woodlawn Barn Visitor’s Center. Provide a grant equal to the  
24 lesser of (i) \$50,000 or (ii) the amount of the matching fund

 2 Parks Foundation, Inc. and] the Maryland–National Capital  
 3 Park and Planning Commission for the design, construction,  
 4 repair, renovation, and rehabilitation of the Woodlawn Barn  
 5 Visitor’s Center, including the construction and installation of  
 6 interpretive program exhibits, located in Silver Spring,  
 7 subject to a requirement that the grantee grant and convey a  
 8 historic easement to the Maryland Historical Trust.  
 9 Notwithstanding Section 1(5) of this Act, the matching fund  
 10 may consist of real property, in kind contributions, or funds  
 11 expended prior to the effective date of this Act **BUT AFTER**  
 12 **JUNE 1, 2010. NOTWITHSTANDING SECTION 1(5) OF THIS**  
 13 **ACT, THE GRANTEE HAS UNTIL JUNE 1, 2016, TO**  
 14 **PRESENT EVIDENCE THAT A MATCHING FUND WILL BE**  
 15 **PROVIDED. NOTWITHSTANDING SECTION 1(7) OF THIS**  
 16 **ACT, THIS GRANT MAY NOT TERMINATE BEFORE**  
 17 **DECEMBER 1, 2017** (Montgomery County) ..... 50,000

 21 lesser of (i) \$250,000 or (ii) the amount of the matching fund  
 22 provided, to [the Board of Trustees of the Montgomery County  
 23 Parks Foundation, Inc. and Board of Directors of] the  
 24 Maryland–National Capital Park and Planning Commission  
 25 for the design, construction, repair, renovation, and  
 26 rehabilitation of the Woodlawn Barn Visitor’s Center,  
 27 including the construction and installation of interpretive  
 28 program exhibits, located in Silver Spring, subject to a  
 29 requirement that the grantee grant and convey a historic  
 30 easement to the Maryland Historical Trust. Notwithstanding  
 31 Section 1(5) of this Act, the matching fund may consist of real  
 32 property, in kind contributions, or funds expended prior to the  
 33 effective date of this Act **BUT AFTER JUNE 1, 2010.**  
 34 **NOTWITHSTANDING SECTION 1(5) OF THIS ACT, THE**  
 35 **GRANTEE HAS UNTIL JUNE 1, 2016, TO PRESENT**  
 36 **EVIDENCE THAT A MATCHING FUND WILL BE PROVIDED.**  
 37 **NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THIS**  
 38 **GRANT MAY NOT TERMINATE BEFORE DECEMBER 1, 2017**  
 39 (Montgomery County) ..... 250,000

40 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 41 June 1, 2014.
