A BILL ENTITLED

1 AN ACT concerning

2 **Anne Arundel County – Alcoholic Beverages – Tasting Licenses**

3 FOR the purpose of creating in Anne Arundel County a BWST beer, wine and spirits
4 tasting (on-premises) license; specifying that the BWST license may be issued
5 to certain persons; creating a license fee schedule for a BWST license and
6 altering the fee schedule for a BWT beer and wine (on-premises) tasting license;
7 specifying certain limitations on the amount of alcoholic beverages that may be
8 offered for on-premises consumption; and generally relating to alcoholic
9 beverages licenses in Anne Arundel County.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article 2B – Alcoholic Beverages**

18 8–402.

19 (a) This section applies only in Anne Arundel County.

20 (b) In this section, “Board” means the Anne Arundel County Board of License
21 Commissioners.

1 (c) There is a Class **BWST CORDIAL, BEER, AND WINE**
2 **(ON-PREMISES) TASTING LICENSE**, A BWT beer and wine (on-premises) tasting
3 license, a WS wine sampling (on-premises) license, and a Class WT wine tasting
4 (on-premises) license.

5 (d) (1) **(I) A CLASS BWST LICENSE MAY BE ISSUED ONLY TO A**
6 **HOLDER OF A CLASS BWL BEER, WINE AND LIQUOR (ON-PREMISES) LICENSE.**

7 **(II) A Class BWT license may only be issued to a holder of a**
8 **Class BWL beer, wine and liquor (on-premises) license or a Class BW beer and wine**
9 **(on-sale) license.**

10 (2) The annual fee for a Class BWT license is[:

11 (i) \$50 for a holder of a Class BWL license; and

12 (ii) \$50 for a holder of a Class BW license] **\$150.**

13 **(3) THE ANNUAL FEE FOR A CLASS BWST LICENSE IS \$500.**

14 **[(3)] (4) The annual fee for a Class BWST OR BWT license is in**
15 **addition to the Class BWL or BW annual fee.**

16 **(5) A CLASS BWST LICENSE AUTHORIZES A HOLDER TO**
17 **PERMIT THE ON-PREMISES CONSUMPTION OF THE FOLLOWING ALCOHOLIC**
18 **BEVERAGES FOR TASTING OR SAMPLING PURPOSES ONLY:**

19 **(I) LIQUOR TO BE SERVED IN A QUANTITY OF NOT MORE**
20 **THAN ONE-HALF OUNCE FROM EACH OF ANY OF FIVE BRANDS TO ANY ONE**
21 **PERSON PER DAY;**

22 **(II) LIGHT WINE TO BE SERVED IN A QUANTITY OF NOT**
23 **MORE THAN 1 OUNCE FROM EACH GIVEN BRAND TO ANY ONE PERSON; AND**

24 **(III) BEER TO BE SERVED IN A QUANTITY OF NOT MORE**
25 **THAN 3 OUNCES TO ANY ONE PERSON.**

26 **[(4)] (6) The Class BWT license authorizes a holder to permit the**
27 **on-premises consumption of the following alcoholic beverages for tasting or sampling**
28 **purposes only:**

29 (i) Light wine to be served in a quantity of not more than 1
30 ounce from each given brand to any one person; and

1 (ii) Beer to be served in a quantity of not more than 3 ounces to
2 any one person.

3 (e) (1) The Board may issue a WS (wine sampling) license to bona fide
4 nonprofit organizations.

5 (2) The WS license authorizes the consumption of wine for tasting or
6 sampling purposes:

7 (i) On Class B beer and wine or beer, wine and liquor licensed
8 premises with the consent of the licensee; or

9 (ii) On premises without a permanent alcoholic beverages
10 license.

11 (3) The licensee may not serve more than 2 ounces from each brand to
12 any 1 person.

13 (4) The bona fide nonprofit organization:

14 (i) Shall apply for a WS license at least 15 days prior to the day
15 of issuance; and

16 (ii) May not be issued more than 12 WS licenses in any given
17 license year.

18 (5) The daily license fee is \$15.

19 (6) The WS licensee may bring wine onto Class B licensed premises for
20 sampling or tasting purposes only.

21 (f) (1) A Class WT wine tasting (on-premises) license may only be issued
22 to a holder of a Class BWL license or a holder of a Class BW license.

23 (2) A Class WT wine tasting (on-premises) license authorizes a holder
24 to permit the on-premises consumption for tasting or sampling purposes only of light
25 wine to be served in a quantity of not more than 1 ounce from each given brand to any
26 one person.

27 (3) The annual license fee is:

28 (i) \$150 for a holder of a Class BWL license; and

29 (ii) \$50 for a holder of a Class BW license.

30 (g) The provisions of this section are not restricted by:

1 (1) The provisions in subsection (b) of § 12–107 of this article; and

2 (2) The provisions of law under § 9–102 of this article prohibiting the
3 issuance of 2 licenses for the same premises.

4 (h) In the City of Annapolis, the Mayor and City Council may approve the
5 issuance of a BWT license or a WS license. The fees for the licenses shall be set by the
6 Mayor and City Council.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
8 July 1, 2014.
