# Anne Arundel County – Alcoholic Beverages – Tasting Licenses

3 FOR the purpose of creating in Anne Arundel County a <del>BWST</del> BWLT beer, wine and 4 <del>spirits</del> liquor tasting (on-premises) license; specifying that the <del>BWST</del> BWLT  $\mathbf{5}$ license and BWT licenses may be issued to certain persons; creating a license 6 fee schedule for a <del>BWST</del> BWLT license and altering the fee schedule for a BWT 7 beer and wine (on-premises) tasting license; specifying certain limitations on 8 the amount of alcoholic beverages that may be offered for on-premises 9 consumption; and generally relating to alcoholic beverages licenses in Anne 10 Arundel County.
