1 AN ACT concerning

### Baltimore County – Use of Speed Monitoring Systems

- 3 FOR the purpose of establishing that in Baltimore County a violation recorded by a 4 speed monitoring system may be enforced by the issuance of a citation only if  $\mathbf{5}$ the violation occurred during a certain time period and at the time of the 6 violation the sign designating the school zone is equipped and operated in a 7 certain manner; requiring in Baltimore County that a violation recorded by a 8 speed monitoring system in a school zone be enforced only by a warning if the 9 violation occurred outside of a certain time period or at the time of the violation 10 the sign designating the school zone is not equipped or operated in a certain 11 manner; requiring that a speed monitoring system in Baltimore County be placed and adjusted in a manner that ensures that a recorded image of a motor 12vehicle is made when the motor vehicle is within a certain area in the school 13zone; and generally relating to the use of speed monitoring systems in 1415Baltimore County.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF  $\mathbf{5}$ 6 MARYLAND, That the Laws of Maryland read as follows: 7 **Article – Transportation** 8 21 - 803.1. 9 (b)(1)On each highway where a school zone is established under this 10 section, in accordance with specifications of the State Highway Administration, the State Highway Administration or local authority: 11 12(i) Shall place signs designating the school zone; and 13May place other traffic control devices, including timed (ii) flashing warning lights. 141521 - 809.16 (b)(1)(vi) This section applies to a violation of this subtitle recorded by 17a speed monitoring system that meets the requirements of this subsection and has 18 been placed: 191. A SPEED MONITORING SYSTEM SHALL BE PLACED AND ADJUSTED IN A MANNER THAT ENSURES THAT A RECORDED IMAGE OF A 2122MOTOR VEHICLE IS MADE WHEN THE MOTOR VEHICLE IS BETWEEN 300 AND 350 23FEET PAST THE SIGN DESIGNATING THE SCHOOL ZONE. 24SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 25October 1, 2014.
