A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Medical Assistance Program – Telemedicine**

3 FOR the purpose of requiring the Maryland Medical Assistance Program to provide
4 certain reimbursement for certain services delivered by telemedicine; repealing
5 the limitations on the health care services delivered by telemedicine that are
6 eligible for reimbursement; and generally relating to the Maryland Medical
7 Assistance Program and telemedicine.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article – Health – General**

21 15–105.2.

1 (a) The Program shall reimburse health care providers in accordance with
2 the requirements of Title 19, Subtitle 1, Part IV of this article.

3 (b) [(1) Subject to paragraph (2) of this subsection and unless] **UNLESS**
4 otherwise specifically prohibited or limited by federal or State law, the Program shall
5 reimburse a health care provider for a health care service delivered by telemedicine, as
6 defined in § 15–139 of the Insurance Article, in the same manner as the same health
7 care service is reimbursed when delivered in person.

8 [(2) Reimbursement under paragraph (1) of this subsection is required
9 only for a health care service that:

10 (i) Is medically necessary; and

11 (ii) Is provided:

12 1. For the treatment of cardiovascular disease or stroke;

13 2. In an emergency department setting; and

14 3. When an appropriate specialist is not available.

15 (3) The Department shall adopt regulations to carry out this
16 subsection.]

17 **Article – Insurance**

18 15–139.

19 (a) (1) In this section, “telemedicine” means, as it relates to the delivery of
20 health care services, the use of interactive audio, video, or other telecommunications
21 or electronic technology by a licensed health care provider to deliver a health care
22 service within the scope of practice of the health care provider at a site other than the
23 site at which the patient is located.

24 (2) “Telemedicine” does not include:

25 (i) an audio–only telephone conversation between a health care
26 provider and a patient;

27 (ii) an electronic mail message between a health care provider
28 and a patient; or

29 (iii) a facsimile transmission between a health care provider and
30 a patient.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
2 October 1, 2014.
