Income Tax – Subtraction Modification – Retirement Income and Task Force to Study Senior Emigration

4 FOR the purpose of altering the maximum amount of a subtraction modification 5 allowed under the State income tax for certain retirement income of an 6 individual of a certain age or who is totally disabled or whose spouse is totally 7 disabled; altering the maximum amount of a certain subtraction modification 8 allowed for certain taxable years; establishing a task force to study certain 9 impacts of senior emigration; providing for the composition, chair, and staffing of the Task Force; prohibiting a member of the Task Force from receiving 10 certain compensation, but authorizing the reimbursement of certain expenses; 11 12 requiring the Task Force to study and make recommendations regarding certain 13 matters; requiring the Task Force to report its findings and recommendations to 14 the Governor and the General Assembly on or before a certain date; providing 15 for the termination of certain provisions of this Act; providing for the 16 application of certain provisions of this Act; and generally relating to an income 17 tax subtraction modification for certain retirement income and a task force to 18 study senior emigration.
