# Human Services Children, Youth, and Family Services – Local Management Boards – Study and State Spending – Information Collection and Report

- FOR the purpose of requiring the Department of Legislative Services and the 4 Governor's Office for Children to conduct a certain study of local management  $\mathbf{5}$ 6 boards; providing for the scope of the study; requiring the Department of 7 Legislative Services to report on the findings of the study requiring certain local management boards to provide certain information to the Department of 8 9 Legislative Services by a certain date; requiring certain State agencies to provide certain information on State spending in each county and municipal 10 11 corporation for services and programs for children, youth, and families to the Department by a certain date; requiring the Department to collect certain 12 information and report the information to the General Assembly in a certain 13form by a certain date; and generally relating to local management boards and 14 State spending on services and programs for children, youth, and families. 15
