SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 222335 of the Maryland Constitution, this Act may not be construed to extend or apply to 24the salary or compensation of the State's Attorney of Prince George's County while 25serving in a term of office beginning before the effective date of this Act, but the provisions of this Act concerning the salary or compensation of the State's Attorney of 2627Prince George's County shall take effect at the beginning of the next following term of 28office. This limitation does not apply to an individual appointed or elected after the 29effective date of this Act to fill an expired term.

30 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 31 October 1, 2014.
