17	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18	MARYLAND, That the Laws of Maryland read as follows:

## Article - Transportation

21 (a) The Administration shall construct, reconstruct, and repair State 22 highways as necessary and shall maintain them in good condition.



- 1 (b) The Department may not spend any further funds for the construction of 2 I–95 through Prince George's County that will involve a new or reconstructed segment 3 connecting it to any other highway in Prince George's County.
- (C) (1) The Department may not spend any further funds for the construction of a new highway, arterial, freeway, or expressway in the lands between Viers Mill Road and Northwest Branch described in the 1980 highway needs inventory as the right-of-way reserved for the Rockville Facility in Montgomery County, including the area designated as the Matthew Henson State Park under § 5–1004 of the Natural Resources Article.
- [(c)] (2) This [prohibition] SUBSECTION does not [preclude] PROHIBIT construction in the right—of—way designated as the Rockville Facility of:
- 12 **[**(1)**] (I)** Roadway crossings to facilitate traffic flow and highway 13 safety; or
- 14 **[**(2)**]** (II) A hiker/biker trail in the lands between Viers Mill Road and 15 Northwest Branch.
- 16 **(D) (1)** IN THIS SUBSECTION, "HIGH VOLTAGE ELECTRIC TRANSMISSION LINE" MEANS AN ELECTRIC TRANSMISSION LINE WITH A 18 CAPACITY OF AT LEAST **69** KILOVOLTS.
- 19 (2) THE DEPARTMENT MAY NOT SPEND ANY FURTHER FUNDS
  20 FOR THE ROUTING OR CONSTRUCTION OF A NEW CONTROLLED ACCESS
  21 HIGHWAY OR A MAJOR ARTERIAL ROADWAY WITHIN 1,000 FEET OF A HIGH
  22 VOLTAGE ELECTRIC TRANSMISSION LINE THAT IS LOCATED INSIDE THE
  23 I-95/I-495 CAPITAL BELTWAY IN PRINCE GEORGE'S COUNTY.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2014.
