A BILL ENTITLED

1 AN ACT concerning

2 **Department of Labor, Licensing, and Regulation – Youth Apprenticeship**
3 **Advisory Committee**

4 FOR the purpose of establishing the Youth Apprenticeship Advisory Committee in the
5 Division of Labor and Industry; providing for the composition and duties of the
6 Committee; requiring the Committee to submit a certain report to the General
7 Assembly on or before a certain date each year; defining a certain term; and
8 generally relating to the Youth Apprenticeship Advisory Committee.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Labor and Employment**

17 **11–409.**

18 **(A) IN THIS SECTION, “COMMITTEE” MEANS THE YOUTH**
19 **APPRENTICESHIP ADVISORY COMMITTEE.**

20 **(B) THERE IS A YOUTH APPRENTICESHIP ADVISORY COMMITTEE IN**
21 **THE DIVISION OF LABOR AND INDUSTRY.**

22 **(C) THE COMMITTEE CONSISTS OF THE FOLLOWING MEMBERS:**

1 **(1) THE SECRETARY, OR THE SECRETARY'S DESIGNEE;**

2 **(2) THE STATE SUPERINTENDENT OF SCHOOLS, OR THE STATE**
3 **SUPERINTENDENT'S DESIGNEE;**

4 **(3) THE SECRETARY OF BUSINESS AND ECONOMIC**
5 **DEVELOPMENT, OR THE SECRETARY'S DESIGNEE;**

6 **(4) THE SECRETARY OF JUVENILE SERVICES, OR THE**
7 **SECRETARY'S DESIGNEE;**

8 **(5) THE COMMISSIONER, OR THE COMMISSIONER'S DESIGNEE;**
9 **AND**

10 **(6) THE FOLLOWING MEMBERS, APPOINTED BY THE GOVERNOR:**

11 **(I) TWO REPRESENTATIVES OF THE COUNCIL;**

12 **(II) ONE REPRESENTATIVE OF AN EMPLOYEE**
13 **ORGANIZATION;**

14 **(III) ONE EMPLOYER WHOSE BUSINESS HAS A NONJOINT**
15 **APPRENTICESHIP PROGRAM;**

16 **(IV) ONE REPRESENTATIVE FROM A COMMUNITY COLLEGE;**

17 **(V) ONE INDIVIDUAL WHO HOLDS A DOCTORAL DEGREE AND**
18 **SPECIALIZES IN LABOR ECONOMICS WITH EXPERTISE IN NATIONAL AND**
19 **INTERNATIONAL APPRENTICESHIP SYSTEMS;**

20 **(VI) ONE REPRESENTATIVE OF A NONPROFIT ORGANIZATION**
21 **WHO IS INVOLVED WITH EMPLOYEE TRAINING AND WORKFORCE DEVELOPMENT;**
22 **AND**

23 **(VII) ONE REPRESENTATIVE OF THE MARYLAND CHAMBER**
24 **OF COMMERCE.**

25 **(D) THE COMMITTEE SHALL:**

26 **(1) EVALUATE THE EFFECTIVENESS OF EXISTING HIGH SCHOOL**
27 **YOUTH APPRENTICESHIP PROGRAMS IN THE STATE, OTHER STATES, AND**
28 **OTHER COUNTRIES BASED ON A SYSTEMATIC REVIEW OF SPECIFIED DATA;**

1 **(2) REVIEW AND IDENTIFY:**

2 **(I) WAYS TO IMPLEMENT HIGH SCHOOL YOUTH**
3 **APPRENTICESHIP PROGRAMS IN THE STATE; AND**

4 **(II) MEANS THROUGH WHICH EMPLOYERS AND**
5 **ORGANIZATIONS CAN OBTAIN GRANTS, TAX CREDITS, AND OTHER SUBSIDIES TO**
6 **SUPPORT ESTABLISHMENT AND OPERATION OF HIGH SCHOOL YOUTH**
7 **APPRENTICESHIP PROGRAMS; AND**

8 **(3) SET TARGETS FOR THE NUMBER OF APPRENTICESHIP**
9 **OPPORTUNITIES FOR YOUTH THAT THE STATE SHOULD REACH OVER THE NEXT**
10 **3 YEARS.**

11 **(E) ON OR BEFORE DECEMBER 1 OF EACH YEAR, THE COMMITTEE**
12 **SHALL SUBMIT A REPORT, IN ACCORDANCE WITH § 2-1246 OF THE STATE**
13 **GOVERNMENT ARTICLE, TO THE GENERAL ASSEMBLY REGARDING ANY**
14 **RECOMMENDED LEGISLATION TO PROMOTE HIGH SCHOOL YOUTH**
15 **APPRENTICESHIP PROGRAMS IN THE STATE.**

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2014.
