A BILL ENTITLED

1 AN ACT concerning

2 **State Board of Pharmacy – Registered Pharmacy Interns**

3 FOR the purpose of establishing a system of registration for pharmacy interns;
4 requiring the State Board of Pharmacy to keep certain records; exempting
5 certain pharmacy interns from certain provisions of law; altering certain
6 grounds for discipline of certain applicants or licensees of the Board;
7 authorizing certain appeals and judicial review under certain circumstances;
8 altering the scope of certain rehabilitation committees; authorizing the Board to
9 require a certain examination under certain circumstances; deeming certain
10 pharmacy interns to have consented to submit to certain examinations and to
11 have waived certain claims of privilege; specifying that certain refusals are
12 prima facie evidence of certain incompetence under certain circumstances,
13 subject to a certain exception; prohibiting certain pharmacies from participating
14 in certain activities or allowing certain individuals to make certain
15 representations; authorizing the Board to waive certain requirements for
16 certain programs; altering the scope of a certain requirement for licensure;
17 requiring certain individuals to register and be approved by the Board before
18 practicing pharmacy as a pharmacy intern under the direct supervision of a
19 certain pharmacist; providing the qualifications for a certain pharmacy intern
20 registration; requiring certain pharmacy interns to submit to a certain criminal
21 history records check; requiring certain applicants to the Board to submit
22 certain sets of fingerprints and a certain fee to the Central Repository of the
23 Criminal Justice Information System under certain circumstances; requiring
24 the Central Repository to forward certain information to the Board and certain
25 applicants; requiring the Board to make certain assurances regarding certain
26 information; authorizing certain individuals to contest certain information;
27 requiring certain applicants to provide certain information to the Board and pay
28 a certain fee; requiring the Board to register certain individuals as pharmacy
29 interns under certain circumstances; authorizing the Board to set certain fees
30 under certain circumstances; prohibiting a certain pharmacist from supervising

1 more than a certain number of pharmacy interns; requiring certain pharmacy
 2 interns to provide the Board with certain notifications within a certain number
 3 of days of a certain conviction or entry of a certain plea; providing for the scope
 4 of a pharmacy intern registration; specifying certain duties that a certain
 5 pharmacy intern may not delegate or perform; providing for the expiration and
 6 renewal of the registration of a pharmacy intern; requiring the Board to send
 7 certain notices by certain methods within a certain period of time under certain
 8 circumstances; requiring certain pharmacy interns to display certain
 9 registrations and wear certain identification; authorizing the Board to deny
 10 certain applicants a registration, reprimand or place on probation certain
 11 pharmacy interns, or suspend or revoke certain registrations under certain
 12 circumstances; authorizing the Board to impose certain penalties under certain
 13 circumstances; requiring the Board to adopt certain regulations for certain
 14 purposes; requiring the Board to pay certain penalties into the General Fund
 15 under certain circumstances; prohibiting the surrender of certain registrations
 16 under certain circumstances; authorizing the Board to set certain conditions on
 17 certain surrenders under certain circumstances; prohibiting certain individuals
 18 from practicing, attempting to practice, or offering to practice as a certain
 19 pharmacy intern unless registered by the Board; prohibiting certain individuals
 20 from making certain representations unless registered by the Board; prohibiting
 21 the use of certain terms unless registered by the Board; subjecting certain
 22 persons to certain penalties under certain circumstances; defining certain
 23 terms; and generally relating to the registration of pharmacy interns.

37 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 38 MARYLAND, That the Laws of Maryland read as follows:

39 **Article – Health Occupations**

40 12–101.

1 (g) “Direct supervision” means that a licensed pharmacist is physically
2 available on-site **AND IN THE PRESCRIPTION AREA OR IN AN AREA WHERE**
3 **PHARMACY SERVICES ARE PROVIDED** to supervise the [performance] **PRACTICE** of
4 **PHARMACY AND** delegated pharmacy acts.

5 (t) (1) “Practice pharmacy” means to engage in any of the following
6 activities:

7 (i) Providing pharmaceutical care;

8 (ii) Compounding, dispensing, or distributing prescription drugs
9 or devices;

10 (iii) Compounding or dispensing nonprescription drugs or
11 devices;

12 (iv) Monitoring prescriptions for prescription and
13 nonprescription drugs or devices;

14 (v) Providing information, explanation, or recommendations to
15 patients and health care practitioners about the safe and effective use of prescription
16 or nonprescription drugs or devices;

17 (vi) Identifying and appraising problems concerning the use or
18 monitoring of therapy with drugs or devices;

19 (vii) Acting within the parameters of a therapy management
20 contract, as provided under Subtitle 6A of this title;

21 (viii) Administering [an influenza vaccination, a vaccination for
22 pneumococcal pneumonia or herpes zoster, or any vaccination that has been
23 determined by the Board, with the agreement of the Board of Physicians and the
24 Board of Nursing, to be in the best health interests of the community] **VACCINATIONS**
25 in accordance with § 12–508 of this title;

26 (ix) Delegating a pharmacy act to a registered pharmacy
27 technician, pharmacy student, or an individual engaged in a Board approved
28 pharmacy technician training program;

29 (x) Supervising a delegated pharmacy act performed by a
30 registered pharmacy technician, pharmacy student, or an individual engaged in a
31 Board approved pharmacy technician training program; or

32 (xi) Providing drug therapy management in accordance with §
33 19–713.6 of the Health – General Article.

1 (2) “Practice pharmacy” does not include the operations of a person
2 who holds a permit issued under § 12-6C-03 of this title.

3 **(T-1) “REGISTERED PHARMACY INTERN” MEANS AN INDIVIDUAL WHO IS**
4 **REGISTERED WITH THE BOARD TO PRACTICE PHARMACY UNDER THE DIRECT**
5 **SUPERVISION OF A PHARMACIST.**

7 (b) In addition to the duties set forth elsewhere in this title, the Board shall:

8 (1) Keep a record that includes:

9 (i) The name and place of the business or the home address of
10 each licensed pharmacist [and], each registered pharmacy technician, **AND EACH**
11 **REGISTERED PHARMACY INTERN;**

12 (ii) The facts concerning the issuance of that pharmacist’s
13 license; [and]

14 (iii) The facts concerning the issuance of that pharmacy
15 technician’s registration; **AND**

16 **(IV) THE FACTS CONCERNING THE ISSUANCE OF THAT**
17 **PHARMACY INTERN’S REGISTRATION;**

18 (2) Prepare and deliver to the Governor, the Secretary, and the
19 Maryland Pharmacists Association an annual report that:

20 (i) Summarizes the condition of pharmacy in this State; and

21 (ii) Includes a record of the proceedings of the Board; and

22 (3) Disclose any information contained in a record to any health
23 occupations regulatory board or agency of this State or another state if the health
24 occupations regulatory board or agency of this State or another state requests the
25 information in writing.

27 (a) Except as otherwise provided in this title, an individual shall be licensed
28 by the Board before the individual may practice pharmacy in this State.

29 (b) This section does not apply to a pharmacy student participating in an
30 experiential learning program of a college or school of pharmacy under the supervision
31 of a licensed pharmacist.

1 **(C) THIS SECTION DOES NOT APPLY TO A REGISTERED PHARMACY**
2 **INTERN PRACTICING UNDER THE DIRECT SUPERVISION OF A LICENSED**
3 **PHARMACIST.**

5 (b) Subject to the hearing provisions of § 12–315 of this subtitle, the Board,
6 on the affirmative vote of a majority of its members then serving, may deny a license
7 to any applicant for a pharmacist’s license, reprimand any licensee, place any licensee
8 on probation, or suspend or revoke a license of a pharmacist if the applicant or
9 licensee:

10 (3) Aids an unauthorized individual to practice pharmacy or to
11 represent that the individual is a pharmacist, **A REGISTERED PHARMACY INTERN,**
12 or a registered pharmacy technician;

13 (13) Agrees with an authorized prescriber, **A REGISTERED PHARMACY**
14 **INTERN,** or registered pharmacy technician to prepare or dispense a secret formula
15 prescription;

16 (31) Delegates pharmacy acts that are inappropriate for a registered
17 pharmacy technician, pharmacy student, or pharmacy technician trainee who does not
18 have the education, training, or experience to perform the delegated pharmacy acts;
19 **[or]**

20 (32) Fails to dispense or dispose of prescription drugs or medical
21 supplies in accordance with Title 15, Subtitle 6 of the Health – General Article; **OR**

22 **(33) FAILS TO APPROPRIATELY SUPERVISE A REGISTERED**
23 **PHARMACY INTERN.**

24 12–316.

25 (a) Except as provided in this section for an action under § 12–313 of this
26 subtitle or § 12–6B–09 **OR § 12–6D–11** of this title, any person aggrieved by a final
27 decision of the Board in a contested case, as defined in the Administrative Procedure
28 Act, may:

29 (1) Appeal that decision to the Board of Review; and

30 (2) Then take any further appeal allowed by the Administrative
31 Procedure Act.

1 (b) (1) Any person aggrieved by a final decision of the Board under §
2 12-313 of this subtitle or § 12-6B-09 OR § 12-6D-11 of this title may not appeal to
3 the Secretary or Board of Review but may take a direct judicial appeal.

4 (2) The appeal shall be made as provided for judicial review of final
5 decisions in the Administrative Procedure Act.

7 (b) For purposes of this section, a pharmacist rehabilitation committee
8 evaluates and provides assistance to any pharmacist, **REGISTERED PHARMACY**
9 **INTERN**, or registered pharmacy technician in need of treatment and rehabilitation
10 for alcoholism, drug abuse, chemical dependency, or other physical, emotional, or
11 mental condition.

12 12-320.

13 (a) In investigating an allegation brought against a licensee, **REGISTERED**
14 **PHARMACY INTERN**, or registered pharmacy technician under this title, if the Board
15 has reason to believe that a licensee, **REGISTERED PHARMACY INTERN**, or registered
16 pharmacy technician may cause harm to a person affected by the licensee's practice,
17 **THE ACTS OF A REGISTERED PHARMACY INTERN**, or the acts of a registered
18 pharmacy technician, the Board on its own initiative may direct the licensee,
19 **REGISTERED PHARMACY INTERN**, or registered pharmacy technician to submit to an
20 appropriate examination by a health care provider designated by the Board.

21 (b) In return for the privilege given to a licensee to practice pharmacy, **A**
22 **REGISTERED PHARMACY INTERN TO PRACTICE PHARMACY UNDER THE DIRECT**
23 **SUPERVISION OF A PHARMACIST**, or a registered pharmacy technician to perform
24 delegated pharmacy acts in the State, the licensee, **REGISTERED PHARMACY**
25 **INTERN**, or registered pharmacy technician is deemed to have:

26 (1) Consented to submit to an examination under this section, if
27 requested by the Board in writing; and

28 (2) Waived any claim of privilege as to the testimony or examination
29 reports of a health care provider.

30 (c) The failure or refusal of a licensee, **A REGISTERED PHARMACY INTERN**,
31 or registered pharmacy technician to submit to an examination required under this
32 section is prima facie evidence of the licensee's inability to practice pharmacy
33 competently, **THE REGISTERED PHARMACY INTERN'S INABILITY TO PRACTICE**
34 **PHARMACY COMPETENTLY UNDER THE DIRECT SUPERVISION OF A**
35 **PHARMACIST**, or the registered pharmacy technician's inability to perform delegated
36 pharmacy acts, unless the Board finds that the failure or refusal was beyond the

1 control of the licensee, **REGISTERED PHARMACY INTERN**, or registered pharmacy
2 technician.

3 (d) The Board shall pay the cost of any examination made under this section.

4 12-403.

5 (b) Except as otherwise provided in this section, a pharmacy for which a
6 pharmacy permit has been issued under this title:

7 (9) May not participate in any activity that is a ground for Board
8 action against a licensed pharmacist under § 12-313 of this title [or], a registered
9 pharmacy technician under § 12-6B-09 of this title, **OR A REGISTERED PHARMACY**
10 **INTERN UNDER § 12-6D-11 OF THIS TITLE**;

11 (19) May not allow an unauthorized individual to represent that the
12 individual is a pharmacist, **A REGISTERED PHARMACY INTERN**, or registered
13 pharmacy technician;

14 (c) (1) The Board may waive any of the requirements of this section for
15 [the University of Maryland School of Pharmacy,] **A SCHOOL OF PHARMACY**
16 **LOCATED IN THE STATE, ACCREDITED BY THE ACCREDITATION COUNCIL FOR**
17 **PHARMACY EDUCATION (ACPE)**, for nuclear pharmacy and dental pharmacy
18 experimental and teaching programs.

20 (a) Except as otherwise provided in this title, on or after January 1, 2007, an
21 individual shall be registered and approved by the Board as a pharmacy technician
22 before the individual may perform delegated pharmacy acts.

23 (b) This section does not apply to[:

24 (1) A pharmacy student performing delegated pharmacy acts under
25 the direct supervision of a licensed pharmacist and in accordance with regulations
26 adopted by the Board;

27 (2) **A]** A pharmacy technician trainee under the direct supervision of a
28 licensed pharmacist provided that the individual does not perform delegated

30 (3) An applicant for a license to practice pharmacy under the direct

15 **ACCREDITED BY THE ACPE;**

16 **(2) IS CURRENTLY ENROLLED AND HAS COMPLETED 1 YEAR OF**
17 **PROFESSIONAL PHARMACY EDUCATION IN A DOCTOR OF PHARMACY PROGRAM**
18 **UNDER ACCREDITATION REVIEW BY THE ACPE;**

19 **(3) HAS GRADUATED FROM A DOCTOR OF PHARMACY PROGRAM**
20 **ACCREDITED BY THE ACPE AND HAS APPLIED FOR LICENSURE WITH THE**
21 **BOARD; OR**

22 **(4) IS A GRADUATE OF A FOREIGN SCHOOL OF PHARMACY WHO:**

23 **(I) HAS ESTABLISHED EDUCATIONAL EQUIVALENCY AS**
24 **DETERMINED BY THE BOARD; AND**

25 **(II) HAS PASSED AN EXAMINATION OF ORAL ENGLISH**
26 **APPROVED BY THE BOARD.**

27 **(B) AN APPLICANT SHALL SUBMIT A REQUEST FOR A STATE CRIMINAL**
28 **HISTORY RECORDS CHECK IN ACCORDANCE WITH § 12-6D-04 OF THIS**
29 **SUBTITLE.**

1 **(C) THE BOARD MAY NOT APPROVE AN APPLICATION UNTIL THE STATE**
2 **CRIMINAL HISTORY RECORDS CHECK IS COMPLETED.**

3 **(D) THE APPLICANT SHALL BE OF GOOD MORAL CHARACTER.**

5 **(A) IN THIS SECTION, "CENTRAL REPOSITORY" MEANS THE CRIMINAL**
6 **JUSTICE INFORMATION SYSTEM CENTRAL REPOSITORY OF THE DEPARTMENT**

20 **(D) THE BOARD SHALL ENSURE THAT INFORMATION OBTAINED FROM**
21 **THE CENTRAL REPOSITORY UNDER THIS SUBSECTION:**

22 **(1) IS KEPT CONFIDENTIAL;**

23 **(2) IS NOT REDISSEMINATED; AND**

24 **(3) IS USED ONLY FOR THE REGISTRATION PURPOSE**
25 **AUTHORIZED BY THIS SUBTITLE.**

26 **(E) THE SUBJECT OF A CRIMINAL HISTORY RECORDS CHECK UNDER**
27 **THIS SUBSECTION MAY CONTEST THE CONTENTS OF THE PRINTED STATEMENT**
28 **ISSUED BY THE CENTRAL REPOSITORY AS PROVIDED IN § 10-223 OF THE**
29 **CRIMINAL PROCEDURE ARTICLE.**

1 **(A) AN APPLICANT FOR REGISTRATION SHALL:**

2 **(1) SUBMIT AN APPLICATION TO THE BOARD ON THE FORM THAT**
3 **THE BOARD REQUIRES;**

5 **(I) ENROLLMENT IN A DOCTOR OF PHARMACY PROGRAM;**
