1 AN ACT concerning

2 **Secretary of State and Attorney General – Charitable Enforcement and**
3 **Protection of Charitable Assets**

4 FOR the purpose of authorizing the Attorney General to take certain actions relating
5 to investigations of alleged violations of laws relating to charitable
6 organizations and charitable representatives; repealing the authority of a
7 designee of the Secretary of State to investigate certain violations; repealing
8 certain authority for the legal counsel for the Office of the Secretary of State to
9 administer oaths and examine an individual under oath; providing that a
10 failure of the Attorney General to enforce a certain violation does not constitute
11 a waiver of certain provisions or rights; altering the permissible circuit courts in
12 which the Attorney General may sue for a certain order; adding the issuance of
13 a cease and desist order by the Attorney General to the circumstances in which
14 a person may request a certain hearing; authorizing the Attorney General to
15 make reciprocal agreements with other states for certain purposes; establishing
16 the Charitable Enforcement Fund as a special, nonlapsing fund in the Office of
17 the Secretary of State; specifying the purpose of the Fund; requiring the
18 Secretary of State to administer the Fund; requiring the State Treasurer to hold
19 the Fund and the Comptroller to account for the Fund; specifying the contents
20 of the Fund; specifying the purpose for which the Fund may be used; providing
21 for ~~the investment of money in and~~ expenditures from the Fund; ~~providing that~~
22 ~~a certain provision of law does not apply to the Fund;~~ repealing requirements

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18 MARYLAND, That the Laws of Maryland read as follows:

19 **Article – Business Regulation**

20 Subtitle 2. Powers and Duties of the Secretary of State **AND THE ATTORNEY**
21 **GENERAL.**

22 6–205.

23 (a) (1) The Secretary of State or the [Secretary's designee] **ATTORNEY**
24 **GENERAL** may investigate an alleged violation of this title.

25 (2) (i) In the course of any examination, investigation, or hearing,
26 the Secretary of State **OR THE ATTORNEY GENERAL** may subpoena witnesses,
27 administer oaths, examine an individual under oath, serve written interrogatories,
28 and compel production of records, books, papers, and other documents.

29 (ii) [In the course of any examination, investigation, or hearing,
30 the legal counsel for the Office of the Secretary of State may administer oaths and
31 examine an individual under oath.

32 (iii) Information obtained under this subsection is not admissible
33 in a subsequent criminal proceeding against the person who provided the information.

1 (b) If the Secretary of State **OR THE ATTORNEY GENERAL** finds or has
2 reasonable grounds to believe that a charitable organization, charitable
3 representative, or public safety solicitor has violated this title, the Secretary of State
4 **OR THE ATTORNEY GENERAL** may take [1] ONE or more of the following actions:

5 (1) by mediation with the apparent violators and any representatives
6 they may choose to assist them, enter into a written assurance of discontinuance,
7 written assurance of voluntary compliance, or other settlement agreement with the
8 apparent violators, in accordance with subsection (c) of this section;

9 (2) summarily issue a cease and desist order to the violator, if the
10 Secretary of State **OR THE ATTORNEY GENERAL**:

11 (i) finds that this title has been violated and that the public
12 health, safety, or welfare requires emergency action; and

13 (ii) gives the violator written notice of the order, the reasons for
14 the order, and the right of the violator to request a hearing under subsection (g) of this
15 section; or

16 (3) refer the matter to[:

17 (i) the Attorney General for civil enforcement; or

18 (ii)] the appropriate State's Attorney for prosecution.

19 (c) A settlement agreement under subsection (b)(1) of this section may
20 include one or more of the following stipulations or conditions:

21 (1) payment by the apparent violator of the cost of the investigation;

22 (2) payment by the apparent violator of civil penalties a court could
23 order under this title;

24 (3) payment by the apparent violator of refunds to donors a court
25 could order under this title;

26 (4) payment by the apparent violator of contributions received to
27 charitable or public safety beneficiaries or for charitable or public safety purposes
28 consistent with the beneficiaries named or purposes represented in the charitable or
29 public safety solicitations which generated the contributions; or

30 (5) any other stipulation, condition, or remedy that will correct a
31 violation of this title.

32 (d) An agreement under this section is for conciliation purposes only and
33 does not constitute an admission by any party that the law has been violated.

1 (e) (1) It is a violation of this title to fail to adhere to any provision
2 contained in a settlement agreement.

3 (2) A failure of the Secretary of State **OR THE ATTORNEY GENERAL**
4 to enforce a violation of any provision of a settlement agreement does not constitute a
5 waiver of that or any other provision, or of any right of the Secretary of State **OR THE**
6 **ATTORNEY GENERAL**.

7 (f) [On referral by the Secretary of State, the] **THE** Attorney General may
8 sue in the [Circuit Court for Anne Arundel County] **CIRCUIT COURT FOR THE**
9 **COUNTY IN WHICH THE ALLEGED VIOLATION OCCURRED** for an order that:

10 (1) restrains further violation of this title;

11 (2) restrains the defendant from making further charitable or public
12 safety solicitations in the State;

13 (3) except as provided under § 6-5A-11 of this title, recovers for the
14 State a civil penalty not to exceed \$5,000 for each willful violation of this title;

15 (4) except as provided under § 6-5A-11 of this title, recovers for the
16 State a civil penalty not to exceed \$3,000 for each grossly negligent violation of this
17 title;

18 (5) enforces compliance with this title; or

19 (6) secures any other appropriate relief, including:

20 (i) refunds to donors; and

21 (ii) payment of the charitable or public safety contributions
22 received by the solicitor to charitable or public safety purposes or beneficiaries
23 consistent with the purposes represented or beneficiaries named in the charitable or
24 public safety solicitations which generated the contributions.

25 (g) (1) If the Secretary of State **OR THE ATTORNEY GENERAL** issues a
26 cease and desist order to a person, the person may request a hearing from the
27 Secretary of State.

28 (2) Within 30 days after a request is submitted, the Secretary of State
29 shall hold a hearing in accordance with Title 10, Subtitle 2 of the State Government
30 Article.

13 counsel shall:

14 (1) submit to the Secretary of State an application under oath on the
15 form that the Secretary of State provides;

16 (2) [consent in writing to the jurisdiction and venue of the Circuit
17 Court for Anne Arundel County in actions brought under this title;

18 (3)] pay to the Secretary of State an application fee of:

19 (i) [\$200] **\$250** for registration as a fund-raising counsel; or

20 (ii) [\$300] **\$350** for registration as a professional solicitor;

22 [(4)] **(3)** (i) certify that all taxes due from the applicant to the

31 register and pay a single application fee of [\$200] **\$250** to cover all of the applicant's
32 officers, agents, members, and employees who work in fund-raising, if the applicant
33 lists in the application the name and address of each of them.

1 (2) An applicant for registration as a professional solicitor may
2 register and pay a single application fee of [~~\$300~~] **\$350** to cover all of the applicant's
3 officers, agents, members, associate solicitors, and employees who work in
4 fund-raising, if the applicant:

5 (i) lists in the application the name of each current officer,
6 agent, member, associate solicitor, and employee who works in fund-raising; and

7 (ii) submits to the Secretary of State the name of each person
8 within 10 days after the person starts employment.

9 **(C) OF THE REVENUES COLLECTED FROM THE APPLICATION FEES**

9 instrument of the charitable organization;

10 [(6)] (5) a copy of a letter from the Internal Revenue Service, or other
11 evidence, showing the tax-exempt status of the charitable organization;

12 [(7)] (6) (i) a copy of federal Form 990 that the charitable
13 organization submits to the Internal Revenue Service; or

14 (ii) information that the charitable organization states on a
15 form that the Secretary of State provides;

16 [(8)] (7) (i) an audit by an independent certified public
17 accountant if the gross income from charitable contributions in the most recently
18 completed fiscal year is at least \$500,000; or

19 (ii) a review by an independent certified public accountant if the
20 gross income from charitable contributions in the most recently completed fiscal year
21 is at least \$200,000 but less than \$500,000;

22 [(9)] (8) an affidavit signed by the chairman, president, or other
23 principal officer attesting to the truth of the registration statement and each
24 supporting document;

25 [(10)] (9) (i) a certification that all taxes due from the applicant to
26 the State or to Baltimore City or a county of the State for the preceding fiscal year
27 have been paid, and all taxes the applicant was required to collect and pay over to the
28 State or to Baltimore City or a county of the State for the preceding fiscal year have
29 been collected and paid over; or

4 (a) A charitable organization that collects less than \$25,000 in charitable
5 contributions from the public in a year need not pay an annual fee, except that, if the
6 charitable organization uses a professional solicitor, it shall pay an annual fee of \$50.

7 (b) (1) Each charitable organization that submits a separate registration
8 statement and collects at least \$25,000 in charitable contributions from the public in a
9 year shall pay an annual fee based on the charitable contributions collected.

10 (2) The annual fee shall be:

11 (i) \$50, if charitable contributions from the public are at least
12 \$25,000 but less than \$50,001;

13 (ii) \$75, if charitable contributions from the public are at least
14 \$50,001 but less than \$75,001;

15 (iii) \$100, if charitable contributions from the public are at least
16 \$75,001 but less than \$100,001; **[and]**

17 (iv) \$200, if charitable contributions from the public are at least

20 charitable solicitation violates this title.

(a) On or before July 1, 2014, the Secretary of State and the Attorney General, or their designees, shall jointly convene and cochair a workgroup to study:

(1) the information that should be reported to the Secretary of State by charitable organizations, charitable representatives, and fund-raising counsel; and

(2) how the information specified in item (1) of this subsection:

(i) can be most effectively and efficiently collected without imposing an unnecessary burden on those subject to reporting; and

(ii) should be shared within and among government agencies or made publicly available to promote the goals of:

1. protecting the public from unscrupulous solicitations and fraud; and

2. facilitating the prevention and correction of any misuse or misapplication of charitable assets.

(b) The workgroup shall include representatives of:

(1) associations of foundations, nonprofit organizations, and professional fund-raisers and fund-raising counsels in the State;

(2) the federal Internal Revenue Service;

(3) the National Association of State Charities Officials;

(4) the Maryland State Bar Association;

(5) the Maryland Association of Certified Public Accountants; and

(6) the general public.
