A BILL ENTITLED

1 AN ACT concerning

2 **Creation of a State Debt – Harford County – Edgewood Community Support**
3 **Center Facility Completion**

4 FOR the purpose of authorizing the creation of a State Debt in the amount of \$50,000,
5 the proceeds to be used as a grant to the Board of Directors of the Edgewood
6 Community Support Center, Inc. for certain development or improvement
7 purposes; providing for disbursement of the loan proceeds; establishing a
8 deadline for the encumbrance or expenditure of the loan proceeds; and providing
9 generally for the issuance and sale of bonds evidencing the loan.

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
11 MARYLAND, That:

12 (1) The Board of Public Works may borrow money and incur indebtedness on
13 behalf of the State of Maryland through a State loan to be known as the Harford
14 County – Edgewood Community Support Center Facility Completion Loan of 2014 in
15 the total principal amount of \$50,000. This loan shall be evidenced by the issuance,
16 sale, and delivery of State general obligation bonds authorized by a resolution of the
17 Board of Public Works and issued, sold, and delivered in accordance with §§ 8–117
18 through 8–124 and 8–131.2 of the State Finance and Procurement Article.

19 (2) The bonds to evidence this loan or installments of this loan may be sold
20 as a single issue or may be consolidated and sold as part of a single issue of bonds
21 under § 8–122 of the State Finance and Procurement Article.

22 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
23 and first shall be applied to the payment of the expenses of issuing, selling, and
24 delivering the bonds, unless funds for this purpose are otherwise provided, and then
25 shall be credited on the books of the Comptroller and expended, on approval by the
26 Board of Public Works, for the following public purposes, including any applicable
27 architects' and engineers' fees: as a grant to the Board of Directors of the Edgewood

1 Community Support Center, Inc. for the acquisition, planning, design, construction,
2 repair, renovation, reconstruction, and capital equipping of the Edgewood Community
3 Support Center Facility, located in Harford County.

4 (4) An annual State tax is imposed on all assessable property in the State in
5 rate and amount sufficient to pay the principal of and interest on the bonds, as and
6 when due and until paid in full. The principal shall be discharged within 15 years
7 after the date of issuance of the bonds.

8 (5) The proceeds of the loan must be expended or encumbered by the Board
9 of Public Works for the purposes provided in this Act no later than June 1, 2021. If any
10 funds authorized by this Act remain unexpended or unencumbered after June 1, 2021,
11 the amount of the unencumbered or unexpended authorization shall be canceled and
12 be of no further effect. If bonds have been issued for the loan, the amount of
13 unexpended or unencumbered bond proceeds shall be disposed of as provided in
14 § 8–129 of the State Finance and Procurement Article.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 June 1, 2014.
