## A BILL ENTITLED

1 AN ACT concerning

2 **Limited Lines – Travel Insurance**

3 FOR the purpose of altering certain provisions of law on limited lines insurance for  
4 transportation tickets to relate instead to limited lines travel insurance;  
5 authorizing the Maryland Insurance Commissioner to issue a limited lines  
6 license to an individual or a business entity to sell travel insurance; authorizing  
7 a travel retailer to offer and disseminate travel insurance under certain  
8 circumstances under the direction of a limited lines travel insurance producer;  
9 requiring a limited lines travel insurance producer or travel retailer to provide  
10 certain information to purchasers of travel insurance; requiring a limited lines  
11 travel insurance producer to establish and maintain a certain register  
12 containing certain information subject to inspection by the Commissioner;  
13 requiring a limited lines travel insurance producer to designate a certain  
14 employee as a responsible person for certain purposes; requiring certain persons  
15 to comply with certain requirements of State insurance law; requiring a limited  
16 lines travel insurance producer to be in good standing; requiring a limited lines  
17 travel insurance producer to require certain travel retailer employees to receive  
18 certain instruction or training with certain required content; requiring a travel  
19 retailer to make available to prospective purchasers certain information  
20 concerning travel insurance and producers; prohibiting certain unlicensed  
21 employees of a travel retailer from evaluating or providing certain advice  
22 concerning travel insurance or holding themselves out as qualified in certain  
23 manners; authorizing certain travel retailers to be compensated in a certain  
24 manner notwithstanding any other law; authorizing certain persons to  
25 compensate certain employees of a travel retailer or authorized representative  
26 in a certain manner; providing that a limited lines travel insurance producer is  
27 responsible for the acts of a travel retailer; requiring a limited lines travel  
28 insurance producer to use reasonable means to ensure certain compliance with  
29 this Act; altering a prohibition on payment of certain commissions or other

8 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
9 MARYLAND, That the Laws of Maryland read as follows:

10 **Article – Insurance**

11 10–101.

12 (a) In this subtitle the following words have the meanings indicated.

13 (b) “Business entity” means a corporation, professional association,  
14 partnership, limited liability company, limited liability partnership, or other legal  
15 entity.

16 (c) “Home state” means any state in which an insurance producer:

17 (1) maintains the insurance producer’s principal place of residence or  
18 principal place of business; and

19 (2) is licensed to act as a resident insurance producer.

20 (d) (1) “License” means a document issued by the Commissioner to act as  
21 an insurance producer for the kind or subdivision of insurance or combination of kinds  
22 or subdivisions of insurance specified in the document.

23 (2) “License” includes a limited lines license.

24 (e) “Limited line credit insurance” includes:

25 (1) credit life insurance;

26 (2) credit health insurance;

27 (3) credit property insurance;

28 (4) credit unemployment insurance;

29 (5) credit involuntary unemployment benefit insurance;

- 1 (6) mortgage life insurance;
- 2 (7) mortgage guaranty insurance;
- 3 (8) mortgage disability insurance;
- 4 (9) guaranteed automobile protection (GAP) insurance; and
- 5 (10) any other form of insurance that:
- 6 (i) is offered in connection with an extension of credit;
- 7 (ii) is limited to partially or wholly extinguishing that credit
- 8 obligation; and
- 9 (iii) the Commissioner determines should be designated a form
- 10 of limited line credit insurance.

11 (f) “Limited line credit insurance producer” means a person who sells,

12 solicits, or negotiates one or more forms of limited line credit insurance coverage to

13 individuals through a master, corporate, group, or individual policy.

14 (g) “Limited lines insurance” means:

- 15 (1) limited line credit insurance;
- 16 (2) the lines of insurance described in §§ 10–122 through 10–125 of
- 17 this subtitle;
- 18 (3) insurance sold in connection with, and incidental to, the rental of a
- 19 motor vehicle under Subtitle 6 of this title; or
- 20 (4) any other line of insurance that the Commissioner considers
- 21 necessary to recognize for the purpose of complying with § 10–119(d) of this subtitle.

22 (h) “Limited lines insurance producer” means a person authorized by the

23 Commissioner to sell, solicit, or negotiate limited lines insurance.

24 **(I) “LIMITED LINES TRAVEL INSURANCE PRODUCER” MEANS, WITH**

25 **RESPECT TO LIMITED LINES TRAVEL INSURANCE:**

26 **(1) A LICENSED MANAGING GENERAL AGENT OR THIRD PARTY**

27 **ADMINISTRATOR; OR**

28 **(2) A LICENSED INSURANCE PRODUCER OR LIMITED LINES**

29 **INSURANCE PRODUCER.**

1           **(J) (1) “OFFER AND DISSEMINATE” MEANS, WITH RESPECT TO**  
2 **LIMITED LINES TRAVEL INSURANCE, TO PROVIDE GENERAL INFORMATION,**  
3 **INCLUDING A DESCRIPTION OF COVERAGE AND PRICE.**

4           **(2) “OFFER AND DISSEMINATE” INCLUDES PROCESSING AN**  
5 **APPLICATION, COLLECTING PREMIUMS, AND PERFORMING OTHER ACTIVITIES**  
6 **THAT:**

7                   **(I) ARE ALLOWED IN THE STATE WITH RESPECT TO A**  
8 **POLICY OF LIMITED LINES TRAVEL INSURANCE; AND**

9                   **(II) DO NOT REQUIRE A LICENSE IN THE STATE.**

10           **[(i)] (K) (1) “Title insurance producer” means a person that, for**  
11 **compensation, solicits, procures, or negotiates title insurance contracts.**

12                   (2) “Title insurance producer” includes a person that provides escrow,  
13 closing, or settlement services that may result in the issuance of a title insurance  
14 contract.

15                   (3) “Title insurance producer” does not include:

16                           (i) individuals employed and used by title insurance producers  
17 for the performance of clerical and similar office duties;

18                           (ii) a financial institution as defined in § 1–101(i) of the  
19 Financial Institutions Article that does not solicit, procure, or negotiate title insurance  
20 contracts for compensation; or

21                           (iii) a title insurance insurer that is licensed under this article.

22           **[(j)] (L) “Title insurance producer independent contractor” means a person**  
23 **that:**

24                   (1) is licensed to act as a title insurance producer;

25                   (2) provides escrow, closing, or settlement services that may result in  
26 the issuance of a title insurance contract as an independent contractor for, or on behalf  
27 of, a licensed and appointed title insurance producer; and

28                   (3) is not an employee of the licensed and appointed title insurance  
29 producer.

30           **[(k)] (M) “Trade name” means a name, symbol, or word, or combination of**  
31 **two or more of these that a person uses to:**

- 1 (1) identify its business, occupation, or self in a business capacity; and  
2 (2) be distinguished from another business, occupation, or person.

3 (N) (1) **“TRAVEL INSURANCE” MEANS INSURANCE COVERAGE FOR**  
4 **PERSONAL RISK INCIDENT TO PLANNED TRAVEL, INCLUDING:**

5 (I) **INTERRUPTION OR CANCELLATION OF A TRIP OR AN**  
6 **EVENT;**

7 (II) **LOSS OF BAGGAGE OR PERSONAL EFFECTS;**

8 (III) **DAMAGE TO ACCOMMODATIONS OR A RENTAL VEHICLE;**  
9 **OR**

10 (IV) **SICKNESS, ACCIDENT, DISABILITY, OR DEATH**  
11 **OCCURRING DURING TRAVEL.**

12 (2) **“TRAVEL INSURANCE” DOES NOT INCLUDE A MAJOR MEDICAL**  
13 **PLAN THAT PROVIDES COMPREHENSIVE MEDICAL PROTECTION FOR A**  
14 **TRAVELER ON A TRIP LASTING 6 MONTHS OR LONGER, SUCH AS AN INDIVIDUAL**  
15 **WORKING OUTSIDE THE UNITED STATES OR MILITARY PERSONNEL BEING**  
16 **DEPLOYED.**

17 (O) **“TRAVEL RETAILER” MEANS A BUSINESS ENTITY THAT MAKES,**  
18 **ARRANGES, OR OFFERS TRAVEL SERVICES.**

19 [(l)] (P) **“Uniform application” means the current version of the NAIC**  
20 **uniform application for resident and nonresident insurance producer licensing.**

21 [(m)] (Q) **“Uniform business entity application” means the current version of**  
22 **the NAIC uniform business entity application for resident and nonresident business**  
23 **entities.**

24 10–122.

25 (a) Without regard to the education, experience, or examination  
26 requirements of this subtitle, the Commissioner may issue a limited lines license to an  
27 individual who **OR A BUSINESS ENTITY THAT** sells [transportation tickets of a  
28 common carrier of persons and property] **TRAVEL INSURANCE.**

29 (b) A limited lines license issued under this section authorizes the holder to  
30 act as an insurance producer only as to travel [ticket policies of life insurance, accident  
31 insurance, or baggage] insurance [on personal effects].

1 (c) The Commissioner may require and provide special forms requiring  
2 information the Commissioner considers proper in connection with the application for  
3 or renewal of limited lines licenses issued under this section.

4 (D) (1) (I) NOTWITHSTANDING ANY OTHER LAW, A TRAVEL  
5 RETAILER MAY OFFER AND DISSEMINATE TRAVEL INSURANCE ON BEHALF OF  
6 AND UNDER THE LICENSE OF A LIMITED LINES TRAVEL INSURANCE PRODUCER  
7 ONLY IF THE PROVISIONS OF THIS PARAGRAPH ARE MET.

8 (II) THE LIMITED LINES TRAVEL INSURANCE PRODUCER OR  
9 TRAVEL RETAILER SHALL PROVIDE TO A PURCHASER OF TRAVEL INSURANCE:

10 1. A DESCRIPTION OF THE MATERIAL TERMS OR THE  
11 ACTUAL TERMS OF THE INSURANCE COVERAGE;

12 2. A DESCRIPTION OF THE PROCESS FOR FILING A  
13 CLAIM;

14 3. A DESCRIPTION OF THE REVIEW OR  
15 CANCELLATION PROCESS FOR THE TRAVEL INSURANCE POLICY;

16 4. A DISCLOSURE THAT:

17 A. THE OFFERED INSURANCE COVERAGE MAY  
18 DUPLICATE CERTAIN PROVISIONS OF INSURANCE COVERAGE ALREADY  
19 PROVIDED BY THE PURCHASER'S HOMEOWNER'S INSURANCE, RENTER'S  
20 INSURANCE, HEALTH INSURANCE, OR SIMILAR INSURANCE COVERAGE; AND

21 B. THE PURCHASE OF TRAVEL INSURANCE WOULD  
22 MAKE THE TRAVEL INSURANCE COVERAGE PRIMARY TO ANY OTHER DUPLICATE  
23 OR SIMILAR COVERAGE; AND

24 5. THE IDENTITY AND CONTACT INFORMATION OF  
25 THE INSURER AND LIMITED LINES TRAVEL INSURANCE PRODUCER.

26 (III) 1. AT THE TIME OF LICENSURE, THE LIMITED LINES  
27 TRAVEL INSURANCE PRODUCER SHALL ESTABLISH AND MAINTAIN A REGISTER,  
28 ON A FORM THE COMMISSIONER REQUIRES, OF EACH TRAVEL RETAILER THAT  
29 OFFERS AND DISSEMINATES TRAVEL INSURANCE ON BEHALF OF THE LIMITED  
30 LINES TRAVEL INSURANCE PRODUCER.

31 2. THE LIMITED LINES TRAVEL INSURANCE  
32 PRODUCER SHALL:

1           **A.     SUBMIT THE REGISTER FOR INSPECTION BY THE**  
2 **COMMISSIONER AS THE COMMISSIONER REQUIRES; AND**

3           **B.     INCLUDE IN THE REGISTER THE NAME, ADDRESS,**  
4 **AND CONTACT INFORMATION OF THE TRAVEL RETAILER AND AN OFFICER OR A**  
5 **PERSON WHO DIRECTS OR CONTROLS THE TRAVEL RETAILER'S OPERATIONS,**  
6 **AND THE TRAVEL RETAILER'S FEDERAL TAX IDENTIFICATION NUMBER.**

7           **3.     THE LIMITED LINES TRAVEL INSURANCE**  
8 **PRODUCER SHALL ALSO CERTIFY THAT EACH TRAVEL RETAILER ON THE**  
9 **REGISTER MAINTAINED BY THE LIMITED LINES TRAVEL INSURANCE PRODUCER**  
10 **COMPLIES WITH 18 U.S.C. § 1033.**

11           **(IV) 1.    THE LIMITED LINES TRAVEL INSURANCE**  
12 **PRODUCER SHALL DESIGNATE ONE OF ITS EMPLOYEES WHO HOLDS A LIMITED**  
13 **LINES LICENSE UNDER THIS SECTION AS A DESIGNATED RESPONSIBLE PERSON**  
14 **TO ENSURE THE LIMITED LINES TRAVEL INSURANCE PRODUCER'S COMPLIANCE**  
15 **WITH THE LAWS AND REGULATIONS FOR TRAVEL INSURANCE IN THE STATE.**

16           **2.     THE DESIGNATED RESPONSIBLE PERSON**  
17 **DESCRIBED IN SUBSUBPARAGRAPH 1 OF THIS SUBPARAGRAPH OR THE**  
18 **PRESIDENT, SECRETARY, TREASURER, AND ANY OTHER OFFICER OR PERSON OF**  
19 **THE LIMITED LINES TRAVEL INSURANCE PRODUCER WHO DIRECTS OR**  
20 **CONTROLS THE OPERATIONS OF THE LIMITED LINES TRAVEL INSURANCE**  
21 **PRODUCER SHALL COMPLY WITH FINGERPRINTING REQUIREMENTS**  
22 **APPLICABLE TO INSURANCE PRODUCERS IN THE STATE.**

23           **(V)    THE LIMITED LINES TRAVEL INSURANCE PRODUCER**  
24 **SHALL BE IN GOOD STANDING WITH THE COMMISSIONER WITH RESPECT TO ITS**  
25 **LICENSE.**

26           **(VI) 1.    THE LIMITED LINES TRAVEL INSURANCE**  
27 **PRODUCER SHALL REQUIRE EACH EMPLOYEE OF THE TRAVEL RETAILER WHOSE**  
28 **DUTIES INCLUDE OFFERING AND DISSEMINATING TRAVEL INSURANCE TO**  
29 **RECEIVE A PROGRAM OF INSTRUCTION OR TRAINING, WHICH MAY BE SUBJECT**  
30 **TO REVIEW BY THE COMMISSIONER.**

31           **2.     THE TRAINING MATERIAL SHALL CONTAIN, AT A**  
32 **MINIMUM, INSTRUCTION ON THE TYPES OF INSURANCE OFFERED, ETHICAL**  
33 **SALES PRACTICES, AND REQUIRED DISCLOSURES TO PROSPECTIVE**  
34 **CUSTOMERS.**

1           **(2) A TRAVEL RETAILER OFFERING OR DISSEMINATING TRAVEL**  
2 **INSURANCE ON BEHALF OF A LIMITED LINES TRAVEL INSURANCE PRODUCER**  
3 **SHALL MAKE AVAILABLE TO A PROSPECTIVE PURCHASER BROCHURES OR**  
4 **OTHER WRITTEN MATERIALS THAT:**

5                   **(I) PROVIDE THE IDENTITY AND CONTACT INFORMATION**  
6 **OF THE LIMITED LINES TRAVEL INSURANCE PRODUCER OVERSEEING THE**  
7 **ACTIVITIES OF THE TRAVEL RETAILER;**

8                   **(II) EXPLAIN THAT THE PURCHASE OF TRAVEL INSURANCE**  
9 **IS NOT REQUIRED IN ORDER TO PURCHASE ANY OTHER PRODUCT OR SERVICE**  
10 **FROM THE TRAVEL RETAILER; AND**

11                   **(III) EXPLAIN THAT A TRAVEL RETAILER:**

12                           **1. IS ALLOWED TO PROVIDE GENERAL INFORMATION**  
13 **ABOUT THE INSURANCE OFFERED AND DISSEMINATED BY THE TRAVEL**  
14 **RETAILER, INCLUDING A DESCRIPTION OF THE COVERAGE AND PRICE; BUT**

15                           **2. IS NOT QUALIFIED OR AUTHORIZED TO ANSWER**  
16 **TECHNICAL QUESTIONS ABOUT THE TERMS AND CONDITIONS OF THE**  
17 **INSURANCE OFFERED BY THE TRAVEL RETAILER OR TO EVALUATE THE**  
18 **ADEQUACY OF THE CUSTOMER'S EXISTING INSURANCE COVERAGE.**

19           **(3) A TRAVEL RETAILER'S EMPLOYEE WHO IS NOT LICENSED AS A**  
20 **LIMITED LINES TRAVEL INSURANCE PRODUCER UNDER THIS SECTION MAY NOT:**

21                   **(I) EVALUATE OR INTERPRET THE TECHNICAL TERMS,**  
22 **BENEFITS, AND CONDITIONS OF THE OFFERED TRAVEL INSURANCE COVERAGE;**

23                   **(II) EVALUATE OR PROVIDE ADVICE CONCERNING A**  
24 **PROSPECTIVE PURCHASER'S EXISTING INSURANCE COVERAGE; OR**

25                   **(III) HOLD HIMSELF OR HERSELF OUT AS A LIMITED LINES**  
26 **TRAVEL INSURANCE PRODUCER, ANY OTHER INSURANCE PRODUCER, OR AN**  
27 **INSURANCE EXPERT.**

28           **(4) (I) NOTWITHSTANDING ANY OTHER LAW, A TRAVEL**  
29 **RETAILER WHOSE INSURANCE-RELATED ACTIVITIES ARE LIMITED TO OFFERING**  
30 **AND DISSEMINATING TRAVEL INSURANCE ON BEHALF OF AND UNDER THE**  
31 **DIRECTION OF A LIMITED LINES TRAVEL INSURANCE PRODUCER UNDER THIS**  
32 **SECTION MAY RECEIVE COMPENSATION WHEN LISTED ON A REGISTER**



1 MAINTAINED BY THE LIMITED LINES TRAVEL INSURANCE PRODUCER IN  
2 ACCORDANCE WITH PARAGRAPH (1)(III) OF THIS SUBSECTION.

3 (II) A TRAVEL RETAILER OR AN AUTHORIZED  
4 REPRESENTATIVE OF THE TRAVEL RETAILER MAY COMPENSATE THE  
5 EMPLOYEES OF THE TRAVEL RETAILER OR OF THE AUTHORIZED  
6 REPRESENTATIVE IN A MANNER THAT DOES NOT DEPEND ON THE SALE OF THE  
7 TRAVEL INSURANCE.

8 (5) THE LIMITED LINES TRAVEL INSURANCE PRODUCER:

9 (I) IS RESPONSIBLE FOR THE ACTS OF THE TRAVEL  
10 RETAILER; AND

11 (II) SHALL USE REASONABLE MEANS TO ENSURE  
12 COMPLIANCE BY THE TRAVEL RETAILER WITH THIS SECTION.

13 10–130.

14 (a) Except as otherwise provided in §§ [10–102 and] **10–102**, 10–119, AND  
15 **10–122** of this subtitle, a commission, fee, reward, rebate, or other consideration for  
16 selling, soliciting, or negotiating insurance may not be paid, directly or indirectly, to a  
17 person other than a licensed insurance producer.

18 (b) Except as otherwise provided in this article, for life insurance or health  
19 insurance this section does not prohibit payment to or receipt by a person who  
20 formerly held a license and, if the person acted on behalf of an insurer, an  
21 appointment of:

22 (1) commissions on renewal premiums on existing policies; or

23 (2) other deferred commissions.

24 (c) Unless the payment would violate § 27–209 or § 27–212 of this article, an  
25 insurer or insurance producer may pay or assign commissions, service fees, or other  
26 valuable consideration to an insurance agency or to persons who do not sell, solicit, or  
27 negotiate insurance in the State.

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
29 October 1, 2014.
