$\frac{1}{2}$	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
3	Article - Courts and Judicial Proceedings

5 6	(a) Only the court or an intake officer may authorize detention, community detention, or shelter care for a child who may be in need of supervision or delinquent.
7 8	(b) If a child is taken into custody under this subtitle, the child may be placed in detention or community detention prior to a hearing if:
9	(1) Such action is required to protect the child or others; or
10	(2) The child is likely to leave the jurisdiction of the court.
11 12	(c) A child taken into custody under this subtitle may be placed in emergency shelter care or community detention prior to a hearing if:
13 14	(1) (i) Such action is required to protect the child or person and property of others;
15	(ii) The child is likely to leave the jurisdiction of the court; or
16 17 18	(iii) There is no parent, guardian, or custodian or other person able to provide supervision and care for the child and return the child to the court when required; and
19 20	(2) (i) 1. Continuation of the child in the child's home is contrary to the welfare of the child; and
21 22 23	2. Removal of the child from the child's home is reasonable under the circumstances due to an alleged emergency situation and in order to provide for the safety of the child; or

immediately file a petition to authorize continued detention, community detention, or

1 2 3	(2) A hearing on the petition shall be held not later than the next court day, unless extended for no more than 5 days by the court upon good cause shown.
4 5 6	(3) Reasonable notice, oral or written, stating the time, place, and purpose of the hearing, shall be given to the child and, if they can be found, the child's parents, guardian, or custodian.
7 8 9	(4) Except as provided in paragraph (5) of this subsection, shelter care may not be ordered for a period of more than 30 days unless an adjudicatory or waiver hearing is held.
10 11 12 13	(5) For a child in need of supervision or a delinquent child, shelter care may be extended for an additional period of not more than 30 days if the court finds after a hearing held as part of the adjudication that continued shelter care is consistent with the circumstances stated in subsections (b) and (c) of this section.
14 15	(6) (i) An adjudicatory or waiver hearing shall be held no later than 30 days after the date a petition for detention or community detention is granted.
16 17 18	(ii) If a child is detained or placed in community detention after an adjudicatory hearing, a disposition hearing shall be held no later than 14 days after the adjudicatory hearing.
19 20 21 22	(iii) Detention or community detention time may be extended in increments of not more than 14 days where the petition charges the child with a delinquent act and where the court finds, after a subsequent hearing, that extended detention or community detention is necessary either:
23	1. For the protection of the child; or
24	2. For the protection of the community.
25 26 27 28	(e) (1) Detention or community detention may not be continued beyond emergency detention or community detention unless, upon an order of court after a hearing, the court has found that one or more of the circumstances stated in subsection (b) of this section exist.
29	(2) A court order under this paragraph shall:
30 31	(i) Contain a written determination of whether or not the criteria contained in subsection (c)(1) and (2) of this section have been met; and
32 33	(ii) Specify which of the circumstances stated in subsection (b) of this section exist.

- 1 If the court has not specifically prohibited community (3)2 detention, the Department of Juvenile Services may release the child from detention 3 into community detention and place the child in: 4 1. Shelter care; or 2. 5 The custody of the child's parent, guardian, custodian, 6 or other person able to provide supervision and care for the child and to return the 7 child to court when required. 8 If a child who has been released by the Department of 9 Juvenile Services or the court into community detention violates the conditions of community detention, and it is necessary to protect the child or others, an intake 10 officer may authorize the detention of the child. 11 12 The Department of Juvenile Services shall promptly notify (iii) 13 the court of: 14 1.
