## Rural Maryland Prosperity Investment Fund – Revisions and Extension of Termination Date

4 FOR the purpose of altering certain findings of the General Assembly regarding the 5 Rural Maryland Prosperity Investment Fund; altering the fiscal year through 6 which the Governor is authorized to include an appropriation in the budget bill 7 for the Fund; altering the manner in which disbursements of money 8 appropriated to the Fund are required to be made; requiring that any money 9 received by a regional council under a certain provision of law be used for a 10 certain purpose; altering a certain provision of law to require that only certain 11 grants, rather than all grants, made by the Maryland Agricultural Education 12 and Rural Development Assistance Board from the Fund be made on a competitive basis in accordance with a certain process; extending the 13 14 termination date of the Fund; making conforming changes; making a technical correction; and generally relating to the Rural Maryland Prosperity Investment 15 16 Fund.

1 (8) "Rural community" means an incorporated or unincorporated area 2 of a county or group of counties in a rural area.

### (b) The General Assembly finds that:

- (1) many rural communities in the State face a host of difficult challenges relating to persistent unemployment and poverty, changing technological and economic conditions, an aging population and an out—migration of youth, inadequate access to quality housing, health care and other services, and deteriorating or inadequate transportation, communications, sanitation, and economic development infrastructure;
- 10 (2) Maryland's agricultural and resource—based industries continue to 11 underpin the local economies of rural communities but are increasingly under threat 12 from national and international market competition, urban encroachment and land 13 development pressure, and environmental and regulatory influences;
  - (3) local governments, regional organizations, educational institutions, and private sector service providers have been unable to meet all the economic development, community development, **HEALTH CARE**, and human services needs of Maryland residents in the rural counties and municipal corporations because of a lack of adequate available capacity and resources;
- 19 (4) the objective of the Rural Maryland Prosperity Investment Fund is 20 to help raise the overall standard of living in rural areas to a level that meets or 21 exceeds statewide benchmark averages by [2020] **2030**, while preserving the best 22 aspects of a pastoral heritage and rural way of life;
  - (5) resources provided to the Fund are designed to facilitate significant targeted investments in important economic, **HEALTH CARE**, and community development programs and promote regional and intergovernmental cooperation;
  - (6) these investments will also enable local and regional public and nonprofit organizations to leverage additional nonstate financial and human resources to facilitate the realization of sustainable rural development objectives while the program is in effect; and
    - (7) the Fund will serve the interests of the entire State by:
- 32 (i) encouraging the increase of entrepreneurial activity and 33 commerce and a balanced economy in the State;
- 34 (ii) relieving conditions of unemployment and underemployment 35 in rural areas;

14 15	(2) The Fund is administered by the Rural Maryland Council with the assistance of the Board.
16 17 18 19 20	(3) The purpose of the Fund is to provide funding to rural regional and statewide planning and development organizations, institutions of higher education serving rural communities, rural community development organizations, and local governments acting in partnership with one another to promote the quality of life in rural areas.
21 22 23	(d) Each year, beginning in fiscal year 2008 and continuing through fiscal year [2020] <b>2030</b> , the Governor may include an appropriation in the budget bill for the Fund.
