  - (c) The Department shall establish by regulation the maximum open season for hunting crows which is permissible under federal law, and shall include in its

- regulations such provisions as are permitted under federal law for control of crows at any time they are found to be committing or about to commit depredation upon ornamental or shade trees, agricultural crops, livestock or wildlife, or when concentrated in such numbers and manner as to constitute a health hazard or other nuisance.
- 6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 7 July 1, 2014.
