A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Medical Assistance Program – Telemedicine**

3 FOR the purpose of requiring the Maryland Medical Assistance Program to provide
4 certain reimbursement for certain services delivered by telemedicine; repealing
5 the limitations on the health care services delivered by telemedicine that are
6 eligible for reimbursement; and generally relating to the Maryland Medical
7 Assistance Program and telemedicine.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article – Health – General**

21 15–105.2.

22 (a) The Program shall reimburse health care providers in accordance with
23 the requirements of Title 19, Subtitle 1, Part IV of this article.

1 (b) [(1) Subject to paragraph (2) of this subsection and unless] **UNLESS**
2 otherwise specifically prohibited or limited by federal or State law, the Program shall
3 reimburse a health care provider for a health care service delivered by telemedicine, as
4 defined in § 15–139 of the Insurance Article, in the same manner as the same health
5 care service is reimbursed when delivered in person.

6 [(2) Reimbursement under paragraph (1) of this subsection is required
7 only for a health care service that:

8 (i) Is medically necessary; and

9 (ii) Is provided:

- 10 1. For the treatment of cardiovascular disease or stroke;
- 11 2. In an emergency department setting; and
- 12 3. When an appropriate specialist is not available.

13 (3) The Department shall adopt regulations to carry out this
14 subsection.]

15 **Article – Insurance**

16 15–139.

17 (a) (1) In this section, “telemedicine” means, as it relates to the delivery of
18 health care services, the use of interactive audio, video, or other telecommunications
19 or electronic technology by a licensed health care provider to deliver a health care
20 service within the scope of practice of the health care provider at a site other than the
21 site at which the patient is located.

22 (2) “Telemedicine” does not include:

23 (i) an audio–only telephone conversation between a health care
24 provider and a patient;

25 (ii) an electronic mail message between a health care provider
26 and a patient; or

27 (iii) a facsimile transmission between a health care provider and
28 a patient.

29 **SECTION 2. AND BE IT FURTHER ENACTED,** That this Act shall take effect
30 October 1, 2014.
