A BILL ENTITLED

1 AN ACT concerning

2 **Drunk Driving – Mandatory Participation in Educational Program**

3 FOR the purpose of requiring a court to require a person who is convicted of, or
4 granted probation before judgment for, certain drunk driving offenses to attend
5 a certain educational program offered by the R Adams Cowley Shock Trauma
6 Center; and generally relating to drunk driving.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article – Transportation**

15 **27–107.1.**

16 **IN ADDITION TO ANY OTHER PENALTIES PROVIDED IN THIS TITLE FOR A**
17 **VIOLATION OF ANY OF THE PROVISIONS OF § 21–902(A) OF THIS ARTICLE**
18 **(“DRIVING WHILE UNDER THE INFLUENCE OF ALCOHOL OR UNDER THE**
19 **INFLUENCE OF ALCOHOL PER SE”) OR § 21–902(B) OF THIS ARTICLE (“DRIVING**
20 **WHILE IMPAIRED BY ALCOHOL”), AND IN ADDITION TO ANY OTHER CONDITION**
21 **OF PROBATION, A COURT SHALL REQUIRE A PERSON WHO IS CONVICTED OF, OR**
22 **GRANTED PROBATION UNDER § 6–220 OF THE CRIMINAL PROCEDURE ARTICLE**
23 **FOR, A VIOLATION OF § 21–902(A) OR (B) OF THIS ARTICLE TO ATTEND THE**
24 **1–DAY DRINKING DRIVER MONITOR PROGRAM OFFERED BY THE R ADAMS**

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
