A BILL ENTITLED

1 AN ACT concerning

2 **Montgomery County – Law Enforcement Vehicles – Automated External**
3 **Defibrillator**

4 FOR the purpose of requiring, in Montgomery County, a law enforcement agency’s
5 vehicle used for patrol by a law enforcement officer who is a first responder and
6 trained in the operation and use of an automated external defibrillator (AED) to
7 be equipped with an AED; defining certain terms; and generally relating to law
8 enforcement vehicles.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Public Safety**

17 **3–509.**

18 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE
19 MEANINGS INDICATED.

20 (2) “AUTOMATED EXTERNAL DEFIBRILLATOR” OR “AED” HAS
21 THE MEANING STATED IN § 13–517 OF THE EDUCATION ARTICLE.

22 (3) “FIRST RESPONDER” MEANS AN INDIVIDUAL WHO:

1 **(I) IS AUTHORIZED TO PROVIDE EMERGENCY MEDICAL**
2 **SERVICES IN THE STATE UNDER § 13-516 OF THE EDUCATION ARTICLE; AND**

3 **(II) PROVIDES SERVICES TO AN INDIVIDUAL BEFORE THE**
4 **INDIVIDUAL IS ADMITTED TO A HOSPITAL.**

5 **(4) “LAW ENFORCEMENT AGENCY” MEANS AN AGENCY THAT IS**
6 **LISTED IN § 3-101(E) OF THIS TITLE.**

7 **(B) IN MONTGOMERY COUNTY, A LAW ENFORCEMENT AGENCY’S**
8 **VEHICLE USED FOR PATROL BY A LAW ENFORCEMENT OFFICER WHO IS A FIRST**
9 **RESPONDER AND TRAINED IN THE OPERATION AND USE OF AN AED SHALL BE**
10 **EQUIPPED WITH AN AED.**

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
12 October 1, 2014.
