# State Board of Professional Counselors and Therapists – Cease and Desist Orders and Penalties for Misrepresentation and Practicing Without a License

 $\mathbf{5}$ FOR the purpose of authorizing the State Board of Professional Counselors and 6 Therapists to issue cease and desist orders or obtain injunctive relief for 7 violations of certain provisions of law; altering a certain penalty for practicing, 8 attempting to practice, or offering to practice certain health occupations without 9 a license issued by the State Board of Professional Counselors and Therapists; 10 providing that a person who violates certain provisions of law is subject to a 11 civil fine not exceeding a certain amount to be assessed by the Board in 12 accordance with certain regulations; requiring the Board to pay certain penalties into the State Board of Professional Counselors and Therapists Fund; 13and generally relating to the State Board of Professional Counselors and 14 Therapists and cease and desist orders and penalties for misrepresentation and 15practicing without a license. 16

Except as otherwise provided in this title, unless an individual is certified to practice alcohol and drug counseling, marriage and family therapy, or professional counseling, the individual may not:

(1) Represent to the public by title, by description of services, methods,
or procedures, or otherwise, that the individual is certified by the Board to provide
counseling or therapy services in this State;

29 (2) Use any title, abbreviation, sign, card, or other representation that 30 the individual is a certified professional counselor, certified professional 31 counselor-marriage and family therapist, certified professional counselor-alcohol and 32 drug, certified associate counselor-alcohol and drug, or certified supervised 33 counselor-alcohol and drug; or

8 (a) [Any] A person who violates any provision of this subtitle or § 17–301 of 9 this title is guilty of a misdemeanor and on conviction is subject to a fine not exceeding 10 [\$2,000] **\$5,000** or imprisonment not exceeding 1 year or both.

11 (B) (1) A PERSON WHO VIOLATES ANY PROVISION OF THIS SUBTITLE 12 OR § 17–301 OF THIS TITLE IS SUBJECT TO A CIVIL FINE NOT EXCEEDING 13 \$50,000 TO BE ASSESSED BY THE BOARD IN ACCORDANCE WITH REGULATIONS 14 ADOPTED BY THE BOARD.

# 15 (2) THE BOARD SHALL PAY ANY PENALTY COLLECTED UNDER 16 THIS SUBSECTION INTO THE STATE BOARD OF PROFESSIONAL COUNSELORS 17 AND THERAPISTS FUND.

18 [(b)] (C) Each violation of this subtitle is a separate offense.
