CHAPTER _____

1 AN ACT concerning

2 **State Board of Examiners for Audiologists, Hearing Aid Dispensers, and**
3 **Speech–Language Pathologists – Cease and Desist Orders and Injunctive**
4 **Relief**

5 FOR the purpose of authorizing the State Board of Examiners for Audiologists,
6 Hearing Aid Dispensers, and Speech–Language Pathologists to issue cease and
7 desist orders or obtain injunctive relief for violations of certain provisions of
8 law; authorizing an action to be maintained in the name of the State or the
9 Board to enjoin certain unauthorized practice or conduct that is a ground for
10 certain disciplinary action; authorizing a certain action to be brought by certain
11 persons and in certain locations; providing that proof of certain damages is not
12 required for a certain action; providing that a certain action is in addition to and
13 not instead of certain criminal prosecution or disciplinary action; repealing
14 authorization for the Board to sue to enforce certain provisions of law; and
15 generally relating to the State Board of Examiners for Audiologists, Hearing
16 Aid Dispensers, and Speech–Language Pathologists and cease and desist orders
17 and injunctive relief.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article – Health Occupations**

4 2–312.

5 (a) (1) The Board shall investigate any alleged violation of this title.

6 (2) The Board may issue subpoenas, administer oaths, and examine
7 witnesses.

8 [(b) (1) The Board may sue to enforce any provision of this title by
9 injunction or other appropriate proceeding.

10 (2) An action under this subsection is in addition to and not instead of
11 criminal prosecution under § 2–408 of this title.]

12 **(B) THE BOARD MAY ISSUE A CEASE AND DESIST ORDER OR OBTAIN**
13 **INJUNCTIVE RELIEF FOR A VIOLATION OF ANY PROVISION OF § 2–314 OF THIS**
14 **SUBTITLE OR §§ 2–401 THROUGH 2–402.3 OF THIS TITLE.**

15 **(C) (1) AN ACTION MAY BE MAINTAINED IN THE NAME OF THE STATE**
16 **OR THE BOARD TO ENJOIN:**

17 **(I) CONDUCT THAT IS A GROUND FOR DISCIPLINARY**
18 **ACTION UNDER § 2–314 OF THIS SUBTITLE;**

19 **(II) THE UNAUTHORIZED PRACTICE OF AUDIOLOGY,**
20 **HEARING AID DISPENSING, OR SPEECH–LANGUAGE PATHOLOGY; OR**

21 **(III) AIDING AND ABETTING IN THE UNAUTHORIZED**
22 **PRACTICE OF AUDIOLOGY, HEARING AID DISPENSING, OR SPEECH–LANGUAGE**
23 **PATHOLOGY.**

24 **(2) AN ACTION UNDER THIS SUBSECTION MAY BE BROUGHT BY:**

25 **(I) THE BOARD, IN ITS OWN NAME;**

26 **(II) THE ATTORNEY GENERAL, IN THE NAME OF THE STATE;**

27 **OR**

28 **(III) A STATE’S ATTORNEY, IN THE NAME OF THE STATE.**

1 **(3) AN ACTION UNDER THIS SUBSECTION SHALL BE BROUGHT IN**
2 **THE COUNTY WHERE THE DEFENDANT:**

3 **(I) RESIDES; OR**

4 **(II) ENGAGES IN THE ACT SOUGHT TO BE ENJOINED.**

5 **(4) PROOF OF ACTUAL DAMAGES OR THAT ANY PERSON IS LIKELY**
6 **TO SUSTAIN ANY DAMAGE IF AN INJUNCTION IS NOT GRANTED IS NOT REQUIRED**
7 **FOR AN ACTION UNDER THIS SUBSECTION.**

8 **(5) AN ACTION UNDER THIS SUBSECTION IS IN ADDITION TO AND**
9 **NOT INSTEAD OF DISCIPLINARY ACTION UNDER § 2-314 OF THIS SUBTITLE OR**
10 **CRIMINAL PROSECUTION FOR THE UNAUTHORIZED PRACTICE OF AUDIOLOGY,**
11 **HEARING AID DISPENSING, OR SPEECH-LANGUAGE PATHOLOGY UNDER §§**
12 **2-401 THROUGH 2-402.3 OF THIS TITLE.**

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
14 October 1, 2014.
