2 **Harford County - ~~Liquor Control Board~~ Class H-CC Alcoholic Beverages**  
3 **Licenses**

4 FOR the purpose of ~~authorizing in Harford County the Liquor Control Board to issue a~~  
5 ~~7-day Class D beer (on sale) license to the holder of a Class 5 brewery license;~~  
6 ~~providing for an annual license fee; requiring the Liquor Control Board to~~  
7 ~~decide the number of certain licenses to be issued and to adopt certain~~  
8 ~~regulations;~~ repealing *in Harford County* a certain restriction on the use of a  
9 corporate dining room in an establishment for which a certain Class H-CC  
10 (corporate club/conference center *alcoholic beverages*) license is issued;  
11 authorizing the holder of a Class H-CC license to keep for sale and sell beer,  
12 wine, and liquor in certain other rooms and areas and to hold certain additional  
13 events; ~~authorizing liquor to be consumed throughout the premises for which a~~  
14 ~~stadium license has been issued; authorizing alcoholic beverages to be served in~~  
15 ~~aluminum containers during a baseball game; repealing a certain restriction on~~

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

**Article 2B – Alcoholic Beverages**

12 (n) (6) (i) There is a Class H-CC (corporate club/conference center)  
 13 beer, wine, and liquor license.

14 (ii) The Liquor Control Board may issue the Class H-CC license  
 15 for an establishment with:

16 1. A banquet room, conference room, or meeting room  
 17 that is suitable for public gatherings and equipped with food preparation facilities; and

18 2. Subject to subparagraph (iii) of this paragraph, a  
 19 corporate dining room that is reserved for members of a private club and their guests.

20 (iii) A corporate dining room described in subparagraph (ii)2 of  
 21 this paragraph:

22 1. Shall be equipped for the sale of food; AND

23 2. May be used [only] by a private club of at least 25  
 24 members who pay an annual membership fee[; and

25 3. May not be used for any purpose other than for the  
 26 benefit of the club].

27 (iv) The holder of a Class H-CC license may:

1 1. Keep for sale and sell beer, wine, [or] AND liquor  
2 during an event contracted with another person in [any]:

3 A. ANY of the rooms described in subparagraph (ii) OR  
4 (III) of this paragraph; and [in other]

5 B. OTHER areas of the licensed establishment that are  
6 approved by the Liquor Control Board;

7 2. Hold multiple events in the licensed establishment  
8 simultaneously;

9 3. Contract to provide beer, wine, and liquor at an event  
10 held off the licensed establishment if the event is in Harford County and the holder  
11 also contracts to provide food for consumption at the event; and

12 4. May not hold more than [one] FOUR self-sponsored  
13 [event] EVENTS per year in the banquet, conference, or meeting room.

14 (v) The annual license fee is \$3,000.

15 (vi) Not more than six Class H-CC licenses may be in effect at a  
16 time.

19 (c) ~~The following limitations shall apply:~~

20 (1) ~~All individuals serving beer, wine, or liquor shall hold valid~~  
21 ~~certificates from an alcohol awareness program approved by the Liquor Control Board;~~

22 (2) ~~During a baseball game, liquor [may]:~~

23 (I) ~~MAY only be served on the club level or dining area in which~~  
24 ~~patrons [are] MAY BE seated; BUT~~

25 (II) ~~MAY BE CONSUMED THROUGHOUT THE PREMISES;~~

26 (3) ~~During a baseball game, alcoholic beverages must be served in a~~  
27 ~~plastic, styrofoam, ALUMINUM, or paper container, except that a glass container may~~  
28 ~~be used on the club level [or dining area in which patrons are seated]; and~~

29 (4) ~~[(i) Except on the club level or dining area in which patrons are~~  
30 ~~seated, all beer and wine dispensed during a baseball game shall be dispensed only~~

6 ~~(b) (18) (i) A certificate signed by at least ten citizens who are owners~~  
7 ~~of real estate and registered voters of the precinct in which the business is to be~~  
8 ~~conducted, stating the length of time each has been acquainted with the applicant, or~~  
9 ~~in the case of a corporation with the individuals making the application; that they~~  
10 ~~have examined the application of the applicant and that they have good reason to~~  
11 ~~believe that all the statements contained in this application are true, and that they are~~  
12 ~~of the opinion that the applicant is a suitable person to obtain the license. The~~  
13 ~~certificate must have a statement that the signers of it are familiar with the premises~~  
14 ~~upon which the proposed business is to be conducted, and that they believe the~~  
15 ~~premises are suitable for the conduct of the business of a retail dealer in alcoholic~~  
16 ~~beverages.~~

17 ~~(ii) In St. Mary's County, persons who are owners of real estate~~  
18 ~~within 5 miles of the premises for which a license is sought and registered voters of St.~~  
19 ~~Mary's County shall be those persons signing the certificate.~~

20 ~~(iii) The certificate required by subparagraph (i) of this~~  
21 ~~paragraph is not necessary for applications filed in Dorchester County, Prince George's~~  
22 ~~County, Montgomery County, Anne Arundel County, [and] Baltimore County, AND~~
