3 FOR the purpose of requiring certain rules and regulations for licensing and operating
4 child care centers to ~~require child care centers providing care to children under~~

8 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
9 MARYLAND, That the Laws of Maryland read as follows:

10 **Article – Family Law**

11 5–573.

12 (a) The State Superintendent shall adopt rules and regulations for licensing
13 and operating child care centers.

14 (b) These rules and regulations shall:

15 (1) ensure safe and sanitary conditions in child care centers;

16 (2) ensure proper care, protection, and supervision of children in child
17 care centers;

18 (3) ensure the health of children in child care centers by:

19 (i) monitoring children for signs and symptoms of child abuse;

20 (ii) instructing licensees and staff concerning child abuse
21 detection and reporting;

22 (iii) monitoring health practices to help prevent the spread of
23 disease; and

24 (iv) monitoring the care of infants and children with special
25 needs;

26 (4) promote the sound growth and development of children in child
27 care centers;

28 **(5) PROMOTE PROPER NUTRITION AND DEVELOPMENTALLY**
29 **APPROPRIATE PRACTICES BY:**

1 **(I) ESTABLISHING TRAINING AND POLICIES PROMOTING**
 2 **BREAST-FEEDING;**

3 **(II) 1. REQUIRING COMPLIANCE WITH THE UNITED**
 4 **STATES FOOD AND DRUG ADMINISTRATION CHILD AND ADULT CARE FOOD**

 16 based on guidelines set by the State Superintendent;

 18 all times at least 1 individual who is responsible for supervision of children, including
 19 children on field trips, and who holds a current certificate indicating successful
 20 completion of approved:

23 2. cardiopulmonary resuscitation (CPR) training
 24 through the American Heart Association or through a program with equivalent
 25 standards appropriate for the ages of children for whom care is provided in the child

 29 ratio of at least 1 certificate holder for every 20 children;

[(8) (9) (i) require that a child care center that receives notice of a contaminated drinking water supply from the child care center's supplier of water, in accordance with § 9-410 of the Environment Article or otherwise, send notice of the drinking water contamination to the parent or legal guardian of each child attending the child care center; and

(ii) require that the notice sent by the child care center shall:

1. be sent within 10 business days after receipt of the notice of contamination from the child care center's water supplier;

2. be in writing;

3. identify the contaminants and their levels in the center's water supply; and

4. describe the child care center's plan for dealing with the water contamination problem until the child care center's water is determined by the appropriate authority to be safe for consumption;

[(9) (10) (i) require a child care center to have a written emergency preparedness plan for emergency situations that require evacuation, sheltering in place, or other protection of children, such as in the event of fire, natural disaster, or other threatening situation that may pose a health or safety hazard to the children in the child care center;

(ii) require the plan under item (i) of this item to include:

1. a designated relocation site and evacuation route;

2. procedures for notifying parents or other adults responsible for the child of the relocation;

2 children, including children with special needs;

3 4. procedures for the reassignment of staff duties during
4 an emergency, as appropriate; and

5 5. procedures for communicating with local emergency
6 management officials or other appropriate State or local authorities; and
