### CHAPTER \_\_\_\_\_

1 AN ACT concerning

#### 2 **Motor Vehicles – Exceptional Milk Hauling Permit – Establishment**

3 FOR the purpose of authorizing the State Highway Administration to issue an  
4 exceptional milk hauling permit that authorizes certain axle configurations and  
5 certain increased weight limitations; establishing that the general exceptional  
6 hauling permit for farm products does not apply to the transportation of milk;  
7 providing for the repeal of certain provisions of this Act on a certain date;  
8 requiring the Administration to enter into an agreement with a certain entity to  
9 collect certain data; requiring certain data to be compiled in an annual report;  
10 requiring the Administration to meet annually with a certain entity to review  
11 the annual report; providing for the effective dates of this Act; and generally  
12 relating to the establishment of the exceptional milk hauling permit.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
 13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article – Transportation**

15 24–113.2.

16 (a) Unless otherwise provided by federal law, an exceptional hauling permit  
 17 issued under this section is not valid on the interstate highway system, as defined in §  
 18 8–101(j) of this article.

19 (b) Notwithstanding any other provision of this title, the State Highway  
 20 Administration may issue an exceptional hauling permit for a combination of vehicles  
 21 that:

22 (1) **(I)** Carries farm products as defined in § 10–601(c) of the  
 23 Agriculture Article, ~~EXCEPT FOR OTHER THAN MILK~~, that:

24 [(i)] 1. Are loaded in fields or other off–highway locations;  
 25 and

26 [(ii)] 2. Are the only load of the vehicle; and

27 [(2)] **(II)** Has an axle configuration of not less than six axles and a  
 28 front–to–rear centerline axle spacing of not less than 50 feet; ~~OR~~

29 **(2) (I) CARRIES TO A PROCESSING PLANT RAW LIQUID MILK**  
 30 **THAT IS THE ONLY LOAD ON THE VEHICLE AND IS LOADED FROM BULK LIQUID**  
 31 **MILK STORAGE TANKS AT ONE OR MORE FARM LOCATIONS; AND**

32 **(II) HAS AN AXLE CONFIGURATION OF NOT LESS THAN ~~FIVE~~**  
 33 **SIX AXLES AND A ~~DISTANCE OF AT LEAST 28 FEET BETWEEN THE LAST AXLE ON~~**

1 ~~THE TRACTOR AND THE FIRST AXLE ON THE SEMITRAILER~~ FRONT-TO-REAR  
 2 CENTERLINE AXLE SPACING OF NOT LESS THAN 50 FEET; OR

3 (3) (I) CARRIES TO A PROCESSING PLANT FROM MARCH 1  
 4 UNTIL JUNE 30 RAW LIQUID MILK THAT IS THE ONLY LOAD ON THE VEHICLE  
 5 AND IS LOADED FROM BULK LIQUID MILK STORAGE TANKS AT ONE OR MORE  
 6 FARM LOCATIONS; AND

7 (II) HAS AN AXLE CONFIGURATION OF FIVE AXLES AND A  
 8 DISTANCE OF AT LEAST 28 FEET BETWEEN THE LAST AXLE ON THE TRACTOR  
 9 AND THE FIRST AXLE ON THE SEMITRAILER.

10 (c) A combination of vehicles operating under the authority of an exceptional  
 11 hauling permit issued under subsection (b) of this section shall:

12 (1) Comply with the following weight limits:

13 (i) A maximum of 20,000 pounds gross weight on a single axle;

14 (ii) For any consecutive axle configuration of two or more axles  
 15 on individual vehicles in the combination, the maximum gross weight specified in §  
 16 24–109(c) of this subtitle; and

17 (iii) A maximum of:

18 1. 87,000 pounds gross combination weight ~~FOR A~~  
 19 ~~COMBINATION OF VEHICLES CARRYING FARM PRODUCTS OTHER THAN MILK; OR~~

20 2. ~~90,000~~ 95,000 POUNDS GROSS COMBINATION  
 21 WEIGHT FOR A COMBINATION OF VEHICLES WITH AT LEAST 6 AXLES CARRYING  
 22 MILK; OR

23 3. 88,000 POUNDS GROSS COMBINATION WEIGHT  
 24 FOR A COMBINATION OF VEHICLES WITH 5 AXLES CARRYING MILK;

25 (2) Twice each year, submit to and pass a North American Standard  
 26 Driver/Vehicle Level 1 inspection; and

27 (3) Be allowed a load limit tolerance of only 1,000 pounds for gross  
 28 combination weight and 15% for axle weights.

29 (d) While operating a combination of vehicles under the authority of an  
 30 exceptional hauling permit issued under subsection (b) of this section, a person may  
 31 not:

1 (1) Violate a highway restriction issued by a competent authority;

2 (2) Operate the combination of vehicles on the interstate highway  
3 system, as defined in § 8–101(j) of this article;

4 (3) Operate the combination of vehicles if the combination of vehicles  
5 exceeds any tire weight rating or tire speed restriction adopted under § 25–111 of this  
6 article; or

7 (4) Fail to comply with the terms and conditions of the exceptional  
8 hauling permit.

9 (e) While operating a combination of vehicles under the authority of an  
10 exceptional hauling permit issued under subsection (b) of this section, a person shall  
11 have in the person's possession:

12 (1) The original exceptional hauling permit issued for the vehicle; and

13 (2) For each vehicle in the combination of vehicles, a copy of a valid  
14 North American Standard Driver/Vehicle Level 1 inspection report issued within the  
15 preceding 180 days that shows no out-of-service violations.

16 (f) (1) A violation of this section, regulations adopted to implement this  
17 section, or the terms and conditions of an exceptional hauling permit issued under  
18 subsection (b) of this section shall:

19 (i) Void the authority granted under the exceptional hauling  
20 permit;

21 (ii) Subject the vehicle to all weight requirements and  
22 tolerances specified in this article; and

23 (iii) For a violation of a weight restriction specified in this  
24 section that exceeds 5,000 pounds, subject the exceptional hauling permit to  
25 immediate confiscation by an officer or authorized civilian employee of the  
26 Department of State Police, an officer of the Maryland Transportation Authority  
27 Police, or any police officer.

28 (2) A person who confiscates an exceptional hauling permit under  
29 paragraph (1) of this subsection shall immediately notify the State Highway  
30 Administration.

31 (3) On notification of the confiscation of an exceptional hauling permit,  
32 the State Highway Administration shall review the confiscation, verify the violation of  
33 a weight restriction, and, if the State Highway Administration determines that a  
34 violation did occur, revoke the permit.

1           (4)    An owner or operator of a combination of vehicles may appeal the  
2 revocation of an exceptional hauling permit to the State Highway Administrator or the  
3 Administrator's designee.

4           (g)   (1)    On request from the State Highway Administrator or the  
5 Administrator's designee, weight and delivery records of the holder of an exceptional  
6 hauling permit that are kept in the normal course of business shall be provided by:

7                   (i)    The holder of the exceptional hauling permit; or

8                   (ii)   A facility that receives farm products, as defined in §  
9 10-601(c) of the Agriculture Article, delivered by a vehicle operating under the  
10 authority of an exceptional hauling permit.

11           (2)    If the holder of an exceptional hauling permit or a facility that  
12 receives farm products does not comply with a request under this subsection, the State  
13 Highway Administration may:

14                   (i)    Suspend the holder's exceptional hauling permit; or

15                   (ii)   Prohibit a vehicle from delivering farm products under the  
16 authority of the exceptional hauling permit to the noncompliant facility.

17           (h)   (1)    An applicant for an exceptional hauling permit shall pay to the  
18 State Highway Administration:

19                   (i)    1.    \$250 for the issuance of a new annual permit or the  
20 annual renewal; or

21                           2.    \$30 for the issuance of a 30-day permit;

22                   (ii)   \$1,000 for the reinstatement of a permit that was revoked  
23 under subsection (f)(3) of this section for a first violation; and

24                   (iii)  \$5,000 for the reinstatement of a permit that was revoked  
25 under subsection (f)(3) of this section for a second or subsequent violation within the  
26 prior 24 months.

27           (2)    A fee paid under this subsection is nonrefundable.

28           (i)    Except as otherwise provided in this section, an exceptional hauling  
29 permit is valid for:

30                   (1)    1 year from the date of issuance for an annual permit; or

31                   (2)    30 consecutive days for a 30-day permit.

1 (j) In consultation with the Secretary of State Police, the State Highway  
2 Administration shall adopt regulations to implement this section.

3 (k) (1) An exceptional hauling permit is issued under this section at the  
4 discretion of the State Highway Administrator.

5 (2) The State Highway Administrator may stop issuing or renewing  
6 exceptional hauling permits under this section if the Administrator determines that  
7 the use of the permits is adversely affecting any part of the State highway system.

8 (3) The State Highway Administrator shall promptly report to the  
9 General Assembly, in accordance with § 2-1246 of the State Government Article,  
10 regarding any decision to stop issuing or renewing exceptional hauling permits under  
11 this section and the reason for the decision.

12 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland  
13 read as follows:

14 Article – Transportation

15 24-113.2.

16 (b) Notwithstanding any other provision of this title, the State Highway  
17 Administration may issue an exceptional hauling permit for a combination of vehicles  
18 that:

19 (1) (i) Carries farm products as defined in § 10-601(c) of the  
20 Agriculture Article, other than milk, that:

21 1. Are loaded in fields or other off-highway locations;  
22 and

23 2. Are the only load of the vehicle; and

24 (ii) Has an axle configuration of not less than six axles and a  
25 front-to-rear centerline axle spacing of not less than 50 feet; OR

26 (2) (i) Carries to a processing plant raw liquid milk that is the only  
27 load on the vehicle and is loaded from bulk liquid milk storage tanks at one or more  
28 farm locations; and

29 (ii) Has an axle configuration of not less than six axles and a  
30 distance of at least 28 feet between the last axle on the tractor and the first axle on the  
31 ~~semitrailer~~ front-to-rear centerline axle spacing of not less than 50 feet[; or



1                   (ii) between 90,000 and 95,000 pounds; and

2                   (iii) over 95,000 pounds; and

3                   (2) with respect to a permit issued under § 24-113.2(b)(3) of the  
4 Transportation Article, as enacted by this Act, the total number of vehicles or  
5 combination of vehicles operating under the permit with a gross combination weight:

6                   (i) under 80,000 pounds;

7                   (ii) between 80,000 and 88,000 pounds; and

8                   (iii) over 88,000 pounds.

9                   (b) Data collected under subsection (a) of this section shall be organized by  
10 month and compiled in an annual report.

11                   (c) The State Highway Administration shall meet annually with the  
12 Maryland and Virginia Milk Producers Cooperative Association to review the most  
13 recent annual report compiled under this section.

14                   SECTION 4. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall  
15 take effect October 1, 2016.

16                   SECTION ~~2~~ 5. AND BE IT FURTHER ENACTED, That, except as provided in  
17 Section 4 of this Act, this Act shall take effect October 1, 2014.
