A BILL ENTITLED

1 AN ACT concerning

2 **Teach It Forward Act of 2014**

3 FOR the purpose of requiring the Maryland Higher Education Commission to develop
4 the Maryland Teach It Forward Pilot Program that allows certain students at a
5 certain public institution of higher education to enroll without paying tuition or
6 fees and requires certain students to enter into a binding contract to make
7 certain payments for a certain number of years after graduating; requiring the
8 Commission to select one public institution of higher education to participate in
9 a certain program; establishing a certain duration and a certain number of
10 students participating in a certain program; requiring the Commission to
11 establish a certain amount that must be paid to the State; requiring the
12 Commission to consider certain information when setting a certain amount;
13 authorizing the Commission to specify the circumstances under which no
14 payment is required; requiring the Governor to make a certain appropriation to
15 a certain institution of higher education; requiring certain repayments to be
16 made to a certain State agency and to be deposited into a certain fund;
17 requiring the Commission to identify certain data metrics; requiring a certain
18 public institution of higher education to collect certain data metrics for certain
19 students; authorizing the Commission to establish any other policies or
20 procedures necessary for implementing a certain program; requiring certain
21 reports to be submitted to the Commission and the General Assembly by certain
22 dates; and generally relating to the Maryland Teach It Forward Pilot Program.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article – Education**

4 **SUBTITLE 11. MARYLAND TEACH IT FORWARD PILOT PROGRAM.**

5 **11-1101.**

6 **THE COMMISSION SHALL DEVELOP A PILOT PROGRAM TO BE KNOWN AS**
7 **THE MARYLAND TEACH IT FORWARD PILOT PROGRAM.**

8 **11-1102.**

9 **THE MARYLAND TEACH IT FORWARD PILOT PROGRAM SHALL:**

10 **(1) ALLOW STUDENTS WHO ARE ELIGIBLE FOR IN-STATE TUITION**
11 **STATUS AT A MARYLAND PUBLIC INSTITUTION OF HIGHER EDUCATION AND**
12 **WHO INTEND TO ENROLL IN A TEACHER PREPARATION COURSE OF STUDY TO**
13 **ENROLL IN A MARYLAND PUBLIC INSTITUTION OF HIGHER EDUCATION**
14 **WITHOUT PAYING TUITION OR FEES; AND**

15 **(2) REQUIRE EACH STUDENT PARTICIPATING IN THE MARYLAND**
16 **TEACH IT FORWARD PILOT PROGRAM TO ENTER INTO A BINDING CONTRACT TO**
17 **PAY THE STATE A CERTAIN PERCENTAGE OF THE STUDENT'S ADJUSTED GROSS**
18 **INCOME FOR UP TO 20 YEARS AFTER THE STUDENT GRADUATES.**

19 **11-1103.**

20 **(A) THE COMMISSION SHALL SELECT ONE PUBLIC INSTITUTION OF**
21 **HIGHER EDUCATION TO PARTICIPATE IN THE MARYLAND TEACH IT FORWARD**
22 **PILOT PROGRAM.**

23 **(B) BEGINNING IN THE FALL OF 2015, THE MARYLAND TEACH IT**
24 **FORWARD PILOT PROGRAM SHALL LAST FOR 2 ACADEMIC YEARS.**

25 **(C) THE PARTICIPATING PUBLIC INSTITUTION OF HIGHER EDUCATION**
26 **MAY ENROLL ONLY UP TO 50 STUDENTS PER ACADEMIC YEAR IN THE**
27 **MARYLAND TEACH IT FORWARD PILOT PROGRAM.**

28 **11-1104.**

29 **(A) THE COMMISSION SHALL SPECIFY THE PERCENTAGE OF A**
30 **GRADUATE'S ADJUSTED GROSS INCOME THAT MUST BE PAID TO THE STATE.**

1 **(B) IN DETERMINING THE PERCENTAGE UNDER SUBSECTION (A) OF**
2 **THIS SECTION, THE COMMISSION:**

3 **(1) SHALL CONSIDER:**

4 **(I) THE TOTAL COST OF EDUCATION AT THE**
5 **PARTICIPATING PUBLIC INSTITUTION OF HIGHER EDUCATION; AND**

6 **(II) THE AVERAGE SALARY OF TEACHERS EMPLOYED IN**
7 **MARYLAND; AND**

8 **(2) MAY SPECIFY THAT NO REPAYMENT IS REQUIRED IF THE**
9 **GRADUATE'S ADJUSTED GROSS INCOME IS BELOW A LEVEL SPECIFIED BY THE**
10 **COMMISSION.**

11 **11-1105.**

12 **(A) THE GOVERNOR SHALL PROVIDE IN THE ANNUAL BUDGET OF THE**
13 **PARTICIPATING INSTITUTION OF HIGHER EDUCATION AN AMOUNT EQUIVALENT**
14 **TO THE TUITION AND FEES OTHERWISE OWED BY THE PARTICIPATING**
15 **STUDENTS.**

16 **(B) THE PAYMENTS THAT GRADUATES ARE REQUIRED TO MAKE SHALL**
17 **BE MADE TO THE COMPTROLLER AND SHALL BE DEPOSITED INTO THE STATE'S**
18 **GENERAL FUND.**

19 **11-1106.**

20 **(A) THE COMMISSION SHALL IDENTIFY DATA METRICS REGARDING THE**
21 **SUCCESS OF THE PARTICIPATING STUDENTS INCLUDING COURSE GRADES,**
22 **COURSE COMPLETION RATES, PROGRESS TOWARD A DEGREE, AND**
23 **EMPLOYMENT STATUS AFTER GRADUATION.**

24 **(B) THE PARTICIPATING PUBLIC INSTITUTION OF HIGHER EDUCATION**
25 **SHALL COLLECT THE DATA METRICS IDENTIFIED BY THE COMMISSION FOR**
26 **EACH PARTICIPATING STUDENT AND FOR EACH NONPARTICIPATING STUDENT**
27 **ENROLLED IN A TEACHER PREPARATION COURSE OF STUDY TO COMPARE THE**
28 **IMPACT OF THE MARYLAND TEACH IT FORWARD PILOT PROGRAM ON STUDENT**
29 **SUCCESS.**

30 **11-1107.**

1 **THE COMMISSION MAY ESTABLISH ANY OTHER POLICIES OR**
2 **PROCEDURES NECESSARY TO IMPLEMENT THE MARYLAND TEACH IT FORWARD**
3 **PILOT PROGRAM.**

4 **11-1108.**

5 **(A) ON OR BEFORE DECEMBER 1, 2015, THE PARTICIPATING PUBLIC**
6 **INSTITUTION OF HIGHER EDUCATION SHALL REPORT TO THE COMMISSION AND**
7 **TO THE GENERAL ASSEMBLY, IN ACCORDANCE WITH § 2-1246 OF THE STATE**
8 **GOVERNMENT ARTICLE, ON:**

9 **(1) THE NUMBER OF PARTICIPATING STUDENTS;**

10 **(2) THE DATA METRICS IDENTIFIED BY THE COMMISSION; AND**

11 **(3) THE PERCENTAGE OF THE ADJUSTED GROSS INCOME**
12 **REQUIRED TO BE PAID AFTER GRADUATION.**

13 **(B) ON OR BEFORE DECEMBER 1, 2016, AND EACH YEAR THEREAFTER,**
14 **THE PARTICIPATING PUBLIC INSTITUTION OF HIGHER EDUCATION SHALL**
15 **REPORT TO THE COMMISSION AND TO THE GENERAL ASSEMBLY, IN**
16 **ACCORDANCE WITH § 2-1246 OF THE STATE GOVERNMENT ARTICLE, ON THE**
17 **PERFORMANCE OF THE PARTICIPATING STUDENTS AS COMPARED TO THE**
18 **PERFORMANCE OF THE NONPARTICIPATING STUDENTS FOR EACH DATA METRIC**
19 **IDENTIFIED BY THE COMMISSION.**

20 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**
21 **July 1, 2014.**
