CHAPTER _____

1 AN ACT concerning

2 **State Board of Pharmacy – Registered Pharmacy Interns**

3 FOR the purpose of establishing a system of registration for pharmacy interns;
4 requiring the State Board of Pharmacy to keep certain records; exempting
5 certain pharmacy interns from certain provisions of law; altering certain
6 grounds for discipline of certain applicants or licensees of the Board;
7 authorizing certain appeals and judicial review under certain circumstances;
8 altering the scope of certain rehabilitation committees; authorizing the Board to
9 require a certain examination under certain circumstances; deeming certain
10 pharmacy interns to have consented to submit to certain examinations and to
11 have waived certain claims of privilege; specifying that certain refusals are
12 prima facie evidence of certain incompetence under certain circumstances,
13 subject to a certain exception; prohibiting certain pharmacies from participating
14 in certain activities or allowing certain individuals to make certain

2 certain programs; altering the scope of a certain requirement for licensure;
3 requiring certain individuals to register and be approved by the Board before
4 practicing pharmacy as a pharmacy intern under the direct supervision of a
5 certain pharmacist; providing the qualifications for a certain pharmacy intern
6 registration; requiring certain pharmacy interns to submit to a certain criminal
7 history records check; requiring certain applicants to the Board to submit
8 certain sets of fingerprints and a certain fee to the Central Repository of the
9 Criminal Justice Information System under certain circumstances; requiring
10 the Central Repository to forward certain information to the Board and certain

8 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
9 MARYLAND, That the Laws of Maryland read as follows:

10 **Article – Health Occupations**

11 12–101.

12 (g) “Direct supervision” means that a licensed pharmacist is physically
13 available, NOTWITHSTANDING APPROPRIATE BREAKS, on-site AND IN THE
14 PRESCRIPTION AREA OR IN AN AREA WHERE PHARMACY SERVICES ARE
15 PROVIDED to supervise the [performance] PRACTICE of PHARMACY AND delegated
16 pharmacy acts.

17 (t) (1) “Practice pharmacy” means to engage in any of the following
18 activities:

19 (i) Providing pharmaceutical care;

20 (ii) Compounding, dispensing, or distributing prescription drugs
21 or devices;

22 (iii) Compounding or dispensing nonprescription drugs or
23 devices;

24 (iv) Monitoring prescriptions for prescription and
25 nonprescription drugs or devices;

26 (v) Providing information, explanation, or recommendations to
27 patients and health care practitioners about the safe and effective use of prescription
28 or nonprescription drugs or devices;

29 (vi) Identifying and appraising problems concerning the use or
30 monitoring of therapy with drugs or devices;

31 (vii) Acting within the parameters of a therapy management
32 contract, as provided under Subtitle 6A of this title;

1 (viii) Administering [an influenza vaccination, a vaccination for
2 pneumococcal pneumonia or herpes zoster, or any vaccination that has been
3 determined by the Board, with the agreement of the Board of Physicians and the
4 Board of Nursing, to be in the best health interests of the community] **VACCINATIONS**
5 in accordance with § 12-508 of this title;

6 (ix) Delegating a pharmacy act to a registered pharmacy
7 technician, pharmacy student, or an individual engaged in a Board approved
8 pharmacy technician training program;

9 (x) Supervising a delegated pharmacy act performed by a
10 registered pharmacy technician, pharmacy student, or an individual engaged in a
11 Board approved pharmacy technician training program; or

12 (xi) Providing drug therapy management in accordance with §
13 19-713.6 of the Health – General Article.

14 (2) “Practice pharmacy” does not include the operations of a person
15 who holds a permit issued under § 12-6C-03 of this title.

16 **(T-1) “REGISTERED PHARMACY INTERN” MEANS AN INDIVIDUAL WHO IS**
17 **REGISTERED WITH THE BOARD TO PRACTICE PHARMACY UNDER THE DIRECT**
18 **SUPERVISION OF A PHARMACIST.**

20 (b) In addition to the duties set forth elsewhere in this title, the Board shall:

21 (1) Keep a record that includes:

22 (i) The name and place of the business or the home address of
23 each licensed pharmacist [and], each registered pharmacy technician, **AND EACH**
24 **REGISTERED PHARMACY INTERN;**

25 (ii) The facts concerning the issuance of that pharmacist’s
26 license; [and]

27 (iii) The facts concerning the issuance of that pharmacy
28 technician’s registration; **AND**

29 **(IV) THE FACTS CONCERNING THE ISSUANCE OF THAT**
30 **PHARMACY INTERN’S REGISTRATION;**

31 (2) Prepare and deliver to the Governor, the Secretary, and the
32 Maryland Pharmacists Association an annual report that:

8 (a) Except as otherwise provided in this title, an individual shall be licensed
9 by the Board before the individual may practice pharmacy in this State.

10 (b) This section does not apply to a pharmacy student participating in an
11 experiential learning program of a college or school of pharmacy under the supervision
12 of a licensed pharmacist.

13 **(C) THIS SECTION DOES NOT APPLY TO A REGISTERED PHARMACY**
14 **INTERN PRACTICING UNDER THE DIRECT SUPERVISION OF A LICENSED**

17 (b) Subject to the hearing provisions of § 12-315 of this subtitle, the Board,
18 on the affirmative vote of a majority of its members then serving, may deny a license
19 to any applicant for a pharmacist's license, reprimand any licensee, place any licensee
20 on probation, or suspend or revoke a license of a pharmacist if the applicant or
21 licensee:

22 (3) Aids an unauthorized individual to practice pharmacy or to
23 represent that the individual is a pharmacist, **A REGISTERED PHARMACY INTERN,**
24 or a registered pharmacy technician;

25 (13) Agrees with an authorized prescriber, **A REGISTERED PHARMACY**
26 **INTERN,** or registered pharmacy technician to prepare or dispense a secret formula
27 prescription;

28 (31) Delegates pharmacy acts that are inappropriate for a registered
29 pharmacy technician, pharmacy student, or pharmacy technician trainee who does not
30 have the education, training, or experience to perform the delegated pharmacy acts;
31 **[or]**

32 (32) Fails to dispense or dispose of prescription drugs or medical
33 supplies in accordance with Title 15, Subtitle 6 of the Health – General Article; **OR**

1 **(33) FAILS TO APPROPRIATELY SUPERVISE A REGISTERED**
2 **PHARMACY INTERN.**

3 12-316.

4 (a) Except as provided in this section for an action under § 12-313 of this
5 subtitle or § 12-6B-09 **OR § 12-6D-11** of this title, any person aggrieved by a final
6 decision of the Board in a contested case, as defined in the Administrative Procedure
7 Act, may:

8 (1) Appeal that decision to the Board of Review; and

9 (2) Then take any further appeal allowed by the Administrative
10 Procedure Act.

11 (b) (1) Any person aggrieved by a final decision of the Board under §
12 12-313 of this subtitle or § 12-6B-09 **OR § 12-6D-11** of this title may not appeal to
13 the Secretary or Board of Review but may take a direct judicial appeal.

14 (2) The appeal shall be made as provided for judicial review of final
15 decisions in the Administrative Procedure Act.

17 (b) For purposes of this section, a pharmacist rehabilitation committee
18 evaluates and provides assistance to any pharmacist, **REGISTERED PHARMACY**
19 **INTERN**, or registered pharmacy technician in need of treatment and rehabilitation
20 for alcoholism, drug abuse, chemical dependency, or other physical, emotional, or
21 mental condition.

23 (a) In investigating an allegation brought against a licensee, **REGISTERED**
24 **PHARMACY INTERN**, or registered pharmacy technician under this title, if the Board
25 has reason to believe that a licensee, **REGISTERED PHARMACY INTERN**, or registered
26 pharmacy technician may cause harm to a person affected by the licensee's practice,
27 **THE ACTS OF A REGISTERED PHARMACY INTERN**, or the acts of a registered
28 pharmacy technician, the Board on its own initiative may direct the licensee,
29 **REGISTERED PHARMACY INTERN**, or registered pharmacy technician to submit to an
30 appropriate examination by a health care provider designated by the Board.

31 (b) In return for the privilege given to a licensee to practice pharmacy, **A**
32 **REGISTERED PHARMACY INTERN TO PRACTICE PHARMACY UNDER THE DIRECT**
33 **SUPERVISION OF A PHARMACIST**, or a registered pharmacy technician to perform

1 delegated pharmacy acts in the State, the licensee, **REGISTERED PHARMACY**
2 **INTERN**, or registered pharmacy technician is deemed to have:

3 (1) Consented to submit to an examination under this section, if
4 requested by the Board in writing; and

5 (2) Waived any claim of privilege as to the testimony or examination
6 reports of a health care provider.

7 (c) The failure or refusal of a licensee, **A REGISTERED PHARMACY INTERN**,
8 or registered pharmacy technician to submit to an examination required under this
9 section is prima facie evidence of the licensee's inability to practice pharmacy
10 competently, **THE REGISTERED PHARMACY INTERN'S INABILITY TO PRACTICE**
11 **PHARMACY COMPETENTLY UNDER THE DIRECT SUPERVISION OF A**
12 **PHARMACIST**, or the registered pharmacy technician's inability to perform delegated
13 pharmacy acts, unless the Board finds that the failure or refusal was beyond the
14 control of the licensee, **REGISTERED PHARMACY INTERN**, or registered pharmacy
15 technician.

16 (d) The Board shall pay the cost of any examination made under this section.

17 12-403.

18 (b) Except as otherwise provided in this section, a pharmacy for which a
19 pharmacy permit has been issued under this title:

20 (9) May not participate in any activity that is a ground for Board
21 action against a licensed pharmacist under § 12-313 of this title [or], a registered
22 pharmacy technician under § 12-6B-09 of this title, **OR A REGISTERED PHARMACY**
23 **INTERN UNDER § 12-6D-11 OF THIS TITLE**;

24 (19) May not allow an unauthorized individual to represent that the
25 individual is a pharmacist, **A REGISTERED PHARMACY INTERN**, or registered
26 pharmacy technician;

27 (c) (1) The Board may waive any of the requirements of this section for
28 [the University of Maryland School of Pharmacy,] **A SCHOOL OF PHARMACY**
29 **LOCATED IN THE STATE, ACCREDITED BY THE ACCREDITATION COUNCIL FOR**

2 **ACCREDITED BY THE ACPE AND HAS APPLIED FOR LICENSURE WITH THE**
3 **BOARD; OR**

4 **(4) IS A GRADUATE OF A FOREIGN SCHOOL OF PHARMACY WHO:**

5 **(I) HAS ESTABLISHED EDUCATIONAL EQUIVALENCY AS**
6 **DETERMINED BY THE BOARD; AND**

7 **(II) HAS PASSED AN EXAMINATION OF ORAL ENGLISH**
8 **APPROVED BY THE BOARD.**

9 **(B) AN APPLICANT SHALL SUBMIT A REQUEST FOR A STATE CRIMINAL**
10 **HISTORY RECORDS CHECK IN ACCORDANCE WITH § 12-6D-04 OF THIS**
11 **SUBTITLE.**

12 **(C) THE BOARD MAY NOT APPROVE AN APPLICATION UNTIL THE STATE**
13 **CRIMINAL HISTORY RECORDS CHECK IS COMPLETED.**

14 **(D) THE APPLICANT SHALL BE OF GOOD MORAL CHARACTER.**
