1 AN ACT concerning

2 **Northeastern Maryland Additive Manufacturing Innovation Authority**

3 FOR the purpose of establishing the Northeastern Maryland Additive Manufacturing
4 Innovation Authority; providing for the purposes of the Authority; establishing
5 an Executive Board for the Authority; providing for the composition, chair, and
6 meetings of the Board; requiring that, to the extent practicable, the members of
7 the Board reasonably reflect the geographic, racial, ethnic, cultural, and gender
8 diversity of the State; prohibiting a member of the Board from receiving certain
9 compensation, but authorizing the reimbursement of certain expenses;
10 authorizing the Board to establish certain committees; requiring the Board to
11 appoint an Executive Director with certain duties; requiring the Department of
12 Business and Economic Development, the Cecil County Office of Economic
13 Development, and the Harford County Office of Economic Development jointly
14 to provide staff, office space, and operational support for the Authority;
15 authorizing the Authority to select and retain certain legal counsel, additional
16 staff, and professional consultants; authorizing the Authority to exercise certain
17 powers; requiring the Authority to undertake certain activities to further the
18 purposes of this Act; establishing the applicability of certain other provisions of
19 law to the Authority and its officers and employees and to the Board;
20 authorizing the State and Cecil and Harford counties jointly to finance the
21 Authority and its activities; requiring the Authority to submit certain work
22 programs and budget information to the Department on or before a certain date
23 each year; requiring the Department to review and forward a certain
24 submission and recommendation to the Department of Budget and
25 Management; ~~requiring~~ authorizing the Governor, beginning with a certain

 2 of a certain amount to partially support the ~~Authority; requiring~~ Authority,
 3 contingent on the commitment of Cecil and Harford counties to contribute funds

 5 each year to appropriate funds to the Authority for a certain purpose;

3 Preamble

4 WHEREAS, In March 2012, President Obama announced plans to create the
5 National Network for Manufacturing Innovation to revitalize the manufacturing base
6 in the United States by establishing up to 15 centers for manufacturing innovation
7 throughout the country; and

8 WHEREAS, In March 2013, the pilot project, the National Additive
9 Manufacturing Innovation Institute, awarded funding totaling \$4,500,000 for seven
10 applied research and development partnership projects and, in January 2014, awarded
11 another \$9,000,000 toward 15 projects that will provide \$10,300,000 in matching cost
12 share; and

13 WHEREAS, Legislation has been introduced in the United States Senate and
14 House of Representatives to establish the Network for Manufacturing Innovation
15 Program, with an appropriation of \$600,000,000, for up to 45 centers that are
16 envisioned as regional consortia of businesses, educational institutions, and
17 government agencies that will share existing resources and work together to pilot new
18 products and manufacturing processes, attract jobs, and encourage investment and
19 production in the United States; and

20 WHEREAS, Manufacturing plays a vital role in the economy and has a strong
21 multiplier effect, with each manufacturing job estimated to create nearly three
22 additional jobs in other sectors; and

23 WHEREAS, Additive manufacturing processes, including 3D printing, are
24 already used in a variety of industries and have the potential for use in unlimited
25 additional areas, including defense contracting, biomedical research and patient care,
26 apparel design, and pharmaceutical production; and

27 WHEREAS, The northeastern region of Maryland has significant additive
28 manufacturing technical expertise and infrastructure, including an additive
29 manufacturing facility at Aberdeen Proving Ground, known as the Rapid Technologies
30 and Inspection Branch, which has been used to design, build, test, and advance new
31 technologies quickly, as well as for training students in science, technology,
32 engineering, and mathematics (STEM) fields; and

33 WHEREAS, The northeastern region of the State has leading educational
34 institutions at all levels, including Towson University, Harford Community College,
35 Cecil College, and the Cecil County and Harford County public school systems; and

36 WHEREAS, There is a need to improve the accessibility of and connections
37 between the existing infrastructure, expertise, and educational resources in the region

1 for entrepreneurs, innovators, and small businesses in the developing and growing
2 area of additive manufacturing; now, therefore,

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

18 **(C) (1) THE TERM OF AN APPOINTED MEMBER IS 4 YEARS.**

19 **(2) AT THE END OF A TERM, AN APPOINTED MEMBER CONTINUES**
20 **TO SERVE UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.**

21 **(3) A MEMBER APPOINTED TO FILL A VACANCY IN AN UNEXPIRED**
22 **TERM SERVES ONLY FOR THE REMAINDER OF THE TERM AND UNTIL A**
23 **SUCCESSOR IS APPOINTED AND QUALIFIES.**

24 **(D) THE BOARD SHALL ELECT A CHAIR FROM AMONG ITS MEMBERS.**

25 **(E) A MEMBER OF THE BOARD:**

26 **(1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE**
27 **BOARD; BUT**

28 **(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE**
29 **STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE**
30 **BUDGET.**

1 **(F) (1) BEGINNING ON OR BEFORE AUGUST 1, 2014, AND**
2 **CONTINUING UNTIL JULY 1, 2015, THE BOARD SHALL HOLD AT LEAST ONE**
3 **REGULAR MEETING EACH MONTH.**

4 **(2) AFTER JULY 1, 2015, THE BOARD SHALL HOLD MEETINGS**
